Election of Delegates to SEIU Convention 2012

This coming February, 2012, the members of our Union will be electing 1199SEIU's Delegates to the SEIU's International Convention to be held on May 29-30, 2012 in Denver, Colorado.¹ Delegates to the Convention (which is held once every four years) are elected from each of the local unions within SEIU to set the course of the International union for the coming period: they will elect the International union officers, establish the goals and strategies for the International union's aggressive program of organizing the unorganized and determine the political and legislative priorities to improve the lives of working people.

Our 1199SEIU Constitution provides that all elected Officers (President, Secretary-Treasurer, Executive Vice Presidents and Vice Presidents) are deemed Delegates to the SEIU's Convention by virtue of their election as officers. Thus, 1199SEIU already has approximately 78 Delegates based on our number of elected Officers. However, 1199SEIU is entitled to additional Delegates to the SEIU's Convention based on our number of dues paying members. The Executive Council has decided to elect an additional 189 Delegates to represent the membership.

In recognition of our expanding Regional structure, the Executive Council has determined that these 189 Delegate positions will be elected on a proportionate basis by Region. Based on membership proportions, the following numbers of Delegates will be elected within each Region:

MA Region:	14
NJ Region	4

¹In the event nominations are uncontested, eligible nominees shall be deemed elected by acclamation, without balloting.

ELECTION BOARD

The Executive Council has already appointed an Election Board, with representatives from all Regions of our Union. This Election Board has authority to run the upcoming election, and its decisions with respect to the petitioning process for nominations and on the dates, times and locations of voting, as well as other rules affecting the election, are set forth below or will be otherwise communicated to our membership.

NOMINATION PROCESS²

The Election Board has determined that nominating petitions for Delegates to the SEIU Convention will be available **beginning on December 7, 2011 through January 11, 2012**. Petitions can be picked up on any weekday at the locations and hours set forth below (excluding the Christmas and New Years holidays—contact your regional office for holidays hours).

Petitioning Times:

The NYC headquarters will be open from 9:00 a.m.-6:00 p.m. All other locations will be open from 9:00 a.m.-5:00 p.m. However, each location will open early (at 8:00 a.m.) and will close late (at 6:00 p.m.) on Wednesdays throughout the petitioning period to ensure that petitions are available to the membership.

Eligibility to be a Candidate:

The Executive Council has determined that eligibility to be a candidate for Delegate to the Convention shall be the same as that set forth in the 1199SEIU Constitution to be a candidate for an officer position. The Constitution requires that a candidate for such position must be a member of 1199SEIU⁴ in good standing for at least one year prior to the election.

Required Signatures:

The Executive Council has further determined that to be nominated as a candidate for a Delegate position you must obtain at least the following number of signatures and social security numbers (last 4 digits) of members in good standing who are now employed within your Region:

WHO CAN NOMINATE CANDIDATES FOR OFFICE

Every member in good standing of 1199SEIU has the right to sign nominating petitions for candidates in their Region. Please be sure, however, to sign only *one* petition for each candidate.

DEADLINE FOR NOMINATIONS

All nominating petitions must be filed with the Election Board by submitting them to one of the designated petitioning locations on or before **6:00 p.m. on January 11, 2012**. All petitions must be received by this date. This is a final deadline.

Also, all candidates must file a form signifying their willingness to be a candidate. These forms can be obtained and filed at the same times (and same place) as nominating petitions, but must be submitted **no later than January 11, 2012 at 6:00 p.m.**

CHALLENGE TO PETITIONS

The Election Board will resolve any questions about the sufficiency of the signatures on the nominating petitions or about the qualification of an individual to be a candidate or any other question relating to the nominating process and the certification of candidates. The Election Board will determine the procedures and the time and place for challenging eligibility/nominations. These procedures will be available at all petitioning locations beginning on December 7, 2011 at the times when nominating petitions are available or by calling the Assistant to the Election Board, Cynthia Boston, at: (212) 857-4260.

Elección de Delegados a la Convención del SEIU del año 2012

En febrero del año 2012, los miembros de nuestra Unión elegirán a los Delegados de la 1199SEIU a la Convención Internacional del SEIU que tendrá lugar del 29-30 de Mayo del año 2012 en Denver, Colorado.¹ Los Delegados a la Convención (que se lleva a cabo cada cuatro años) son elegidos de todos los sindicatos locales dentro del SEIU para dar rumbo a la Internacional durante el período siguiente: elegirán a los oficiales de la Internacional, establecerán las metas y las estrategias para el programa agresivo de organizar a los trabajadores no sindicalizados y determinar las prioridades políticas y legislativas para mejorar las vidas de los trabajadores.

Nuestra constitución de 1199SEIU establece que todos los Oficiales elegidos (Presidente, Tesoro-Secretaria, Vice Presidentes Ejecutivos, y Vice Presidentes) son considerados como Delegados a la Convención del SEIU en su capacidad de Oficiales. De esa forma, la 1199SEIU tiene ya aproximadamente 78 Delegados, es decir, la cantidad de Oficiales elegidos. Sin embargo, la 1199SEIU también tiene derecho a otros Delegados a la Convención del SEIU, según la cantidad de miembros que están pagando cotizaciones. El Consejo Ejecutivo ha decidido elegir otros 189 Delegados para representar los miembros.
