THE PEOPLE OF THE STATE OF CALIFORNIA TO ANY SHERIFF, POLICEMAN OR PEACE OFFICER IN THE COUNTY OF TULARE: proof by statement of probable cause having been made before me by Detective Jeremy Ediger that there is probable cause to issue a court order for the release of marijuana plants described herein to the location(s) set forth herein.

YOU ARE THEREFORE COMMANDED TO : Release (8) marijuana plants which were seized on September 29, 2005, from the residence of 2502 S. Conyer Street, City of Visalia, State of California.

ITEMS TO BE RELEASED PURSUANT TO THIS COURT ORDER:

- 1) (8) marijuana plants seized on September 29, 2005, from the residence of 2502 S. Conyer Street, City of Visalia.

The plants were seized pursuant to a search warrant, signed by Honorable Judge Lloyd Hicks, which was executed, by the Visalia Police Department Narcotics Unit at the residence. During the search warrant, officers seized the (8) marijuana plants from the backyard of the residence. The plants were live, and growing in plastic containers. The plants were seized as evidence in the crime of cultivation of marijuana, Section 11358 of the Health and Safety Code.

Pursuant to the seizing of the (8) marijuana plants from 2502 S. Conyer Street, a report of the investigation was provided to the Tulare County District Attorney's Office. After review of the report, the District Attorney's office determined further investigation was needed prior to the filing of the charge of Section 11358 of the Health and Safety Code.

The (8) marijuana plants seized from the residence by the Visalia Police Department were taken as evidence, and have been maintained as evidence. Due to the fact the plants were taken while growing, it is necessary to provide some type of care for them. The Visalia Police Department is unable to provide the proper care needed to maintain the marijuana plants at this time. It is

because of this, it is requested the (8) marijuana plants be returned to Gabriel Perez, 2502 S. Conyer Street, Visalia. A leaf sample, and photos of the plants will be taken at the time the plants are returned to Gabriel Perez residing at 2502 S. Conyer Street, Visalia.

YOU ARE TO RELEASE (8) MARIJUANA PLANTS, photograph the plants, obtain a leaf sample of the plants, and secure that sample into Visalia Police Department Main Evidence facility.
