Dear Senators:

As we agreed to in our letter of February 21, 2014, attached please find a chart of the notifications of cancellations, detailed by county, for individual and employer-provided plans received by the Division.

Please note that the notifications we have received from carriers are for specific products/plans which the carrier is discontinuing. We will specially designate if a carrier is leaving Colorado or a Colorado market segment (individual or small group) entirely. However, we anticipate that most of the cancellations will be for a particular product and thus only part of a carrier's book of business.

When the Division receives notices of cancellation from carriers, we review the letters the carrier sends to consumers to ensure they provide adequate notice to consumers of their options. Insurance Regulation 4-2-44 and Bulletin B-4.50 provide guidance to carriers as to what information must be included in consumer notifications of cancellation, which must contain delineation of options available to the consumer to find replacement coverage.
