Slide 13: A REGIONAL EXAMPLE

Population 58,000:

US Census population data (online inquiry): Glen Rock 11,546; HoHoKus 4,060; Midland Park 6947; Washington Township 8983

Ridgewood 26,243 from a more current newspaper article that I can't locate....if we were to use the US census number it would be 24936 which would result in a total population of 56,472, i.e. not significantly different from the 58,000 and would result in a larger Current Budget on page 15 and thereby bigger projected savings (therefore our stated results would be less than what we indicated).

Slide 14: A REGIONAL EXAMPLE

The number of positions were taken from "Bergen County 2009 County and Municipal Directory" by adding up each of those positions for each of the 5 towns.

Slide 15: THE WHOLE PICTURE:

Current budget is a simple extrapolation of the Ridgewood Regional budget, i.e. \$270 million. We used a more conservative 7% *(representing the percentage of towns and population of the Ridgewood area compared to total Bergen County). *N.B.The population represented 6.4% of Bergen County (or 6.27% if we adjust Ridgewood's numbers to use the census). The towns represent 7.14% of total Bergen County. We used 7% as our number to extrapolate....had we used 6%, our total budget for Bergen County municipalities would have been \$4.5 Billion, a much bigger number yielding a much bigger save. So the numbers we reflected are much more conservative.
