An individual or non-multicandidate federal PAC may contribute a maximum of \$2,700 per election. A multi-candidate Federal PAC may contribute a maximum of \$5,000 per election. The 2020 Primary and 2020 General elections are separate elections. Contributions from corporations, labor organization treasury funds, foreign nationals, and federal government contractors are prohibited. Contributions must be made from the contributor's own funds, not those of another and contributors may not be reimbursed by any other person or entity.

Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 in an election cycle.
