

Administrative law - review decision arising under statute (collective rights)

RELIEF CLAIMED

- 1 A declaration that the purported decision by the Minister to notify the revocation of, and the notification of the intent to revoke, the dedication of Crown Reserves described as D560016 and D560017 being Lot 701 DPNo.1029428 and Lot 587 DPNo 822970 respectively is void and of no effect.
- 2 A declaration that the land so described and dedicated as D560016 and D560017 may not be dealt with by the Minister under the *Crown Lands Act 1989* on the basis that the statutory steps to notify the revocation of the Crown Reserves have not been validly taken, ~~is and continues to be subject to a dedication for the public purpose of Public Recreation.~~
- ~~3 An order restraining the Minister from dealing with the said land otherwise than in accordance with the provisions of the Crown Land Act 1989 applicable to reserve land.~~
- 3A Further and in the alternative an order restraining the Minister from taking any step in reliance on the purported notice of intent to revoke Crown Reserve to remove the recording on the Register of the dedication of Crown Reserves described as

D560016 and D560017 in respect of Lot 701 DP No. 1029428 and Lot 587 DP No 822970 respectively.

- 4 An order that the Respondent pay the Applicant's costs of the proceedings.
- 5 Such further or other orders as the Court thinks fit.


