

Introduction

The *Friends of the Greenbelt Foundation* is an arm's-length organization managing its affairs independently of government. As such, it is not subject to provincial government regulations pertaining to information and privacy. However, as an institution that allocates public funds, we are committed to public transparency and accountability. We are equally committed to respecting and protecting the legitimate rights to the privacy of individuals and organizations with whom we work.

The *Friends of the Greenbelt Foundation* operates under the Ontario Protection and Privacy Act.

Information

2.1. About the Foundation

Members of the Board of Directors, Advisory Committee and other Committees
Names will be provided with the main *Friends of the Greenbelt Foundation* office address, telephone and fax numbers. Personal and business addresses and telephone numbers will not be disclosed unless authorized by the individual concerned.

Staff

Names, titles, office and e-mail addresses, and office telephone and fax numbers will be provided. Personal addresses and telephone numbers will not be disclosed unless authorized.

Documents created by the Foundation

All documents approved by the Board of Directors for public release will be made available. A list of

information available to the public appears in Appendix A. The Executive Director and/or Chair of the Board should be consulted before draft documents are made available to individuals outside the *Foundation*.

2.2. About Applicants and Grantees

Applicants provide information to the *Foundation* about themselves, their past and future projects and their finances as part of each grant application. The data is reviewed in order to process and assess applications and for the distribution of grants. The data is made available to assessors for the purpose of this grant decision making.

The *Foundation* does not provide information about organizations applying for funding until a decision to fund has been made. After a funding decision has been made, the *Foundation* provides specific information to the public about the organizations it funds as per Appendix A, but will not provide detailed information on any applicants whether approved or declined for funding. Applicants may disclose this information if they wish, but the *Foundation* will treat it as confidential.

2.2.1. About Unsuccessful Applicants

The *Foundation* will provide global information that will enable members of the public to understand how our funding is being allocated. However, the *Foundation* will not release information about specific organizations that were declined funding. These organizations may of course disclose the information themselves. The quality of our applications is high and the process is competitive. It can be assumed that applicants denied for funding did not meet the *Foundation's* program goals as thoroughly as those who were successful.

2.2.2. About Grantees (Qualified and Non-Qualified)

Upon request, the *Foundation* normally will provide the name of funded organizations, including the name of a contact in the organization, telephone number, address, grant amount and duration, and a brief description of project/activity funded. If the funded organization requests the *Foundation* not to disclose certain information because to do so could put the organization or their clients at risk, the *Foundation* may choose to withhold that information.

2.3. About Other Organizations

In order to carry out its mandate, the *Foundation* acquires information from various sources, including grant applicants, suppliers, government, public and private foundations, and other charitable and non-profit organizations. Members of the public requesting information the *Foundation* has obtained from other organizations, which include, but are not limited to the above, normally will be directed to the original source of the information.

Information Sharing

Consistent with its goals, the *Foundation* will promote collaboration by helping to coordinate the efforts of groups with an interest in Greenbelt activities and adopting a convening function to encourage and foster relationships among different organizations and communities. The *Foundation* may exchange information and analysis on a confidential basis with other funders, research institutions, and government departments when it is in the public interest to do so. For example, information could be exchanged to improve granting procedures, establish best practices, and encourage innovative cross-sectoral initiatives.

Special Requests

The *Friends of the Greenbelt Foundation* is committed to responding promptly and fully to requests for information related to its operations and mandate. However, staff will not undertake additional research and analysis in order to respond to special requests for information unless there are clear public benefits that justify the time and expense.

Information Maintenance and Security

Access to confidential and personal information is limited to those whose work requires it. The *Foundation* ensures that financial and other records are maintained for as long as required by government regulations. An agreement with the Archives of Ontario may be established for procedures for disposing of material that ensures that documents of public value are stored. This is dependant on successful negotiations with the Archives.

Contact Lists

The *Foundation's* contact lists are only to be used for carrying out the ongoing business of the *Foundation* according to the Policy adopted by the Board of Directors on September 11, 2006.

Appendix B

Policy of Foundation Contact List

Background

The *Friends of the Greenbelt Foundation* maintains a number of contact lists in the course of its operations. Lists typically include names, addresses, telephone, e-mail details and other contact information. These include lists of:

- Grantee organizations
- Applicant organizations
- Government and Funder contacts
- Accounts Payable vendors
- Board members
- Foundation volunteers
- Staff

Policy on Use of Contact Lists

The Policy on the use of contact lists is based on Ontario's Freedom of Information and Protection of Privacy Act, and the principle that the *Foundation* is required to protect the privacy of personal information in its possession. This Policy translates into the following practice:

The *Foundation's* contact lists are only to be used for carrying out the ongoing business of the *Foundation*. The Executive Director will authorize or delegate the use of such lists, in conducting such day-to-day business.

The Executive Director will not authorize use of the contact list for any purpose other than the ongoing business of the *Foundation*.

When the Executive Director deems that a request to use a contact list is not within the commonly understood definition of "ongoing business of the *Foundation*," they will turn the matter over to the Board of Directors for a decision. The Board of Directors will authorize use only if it is satisfied that the recommended use will support the objectives and business plan of the *Friends of the Greenbelt Foundation*.

Appendix C

Consent Form - Database of Greenbelt Growers

Background

The *Friends of the Greenbelt Foundation* has developed a searchable database of growers and producers in the Greenbelt and their crops. The following is the consent form that must be signed and dated by all those who submit their data to the *Foundation*.

Privacy and Consent Form

I understand that the *Friends of the Greenbelt Foundation*, the Ontario Culinary Tourism Alliance and the Greater Toronto Area Agricultural Action Committee are gathering personal information and other information for the purpose of assisting growers and producers to tell the public about their crops/farm products and to help buyers of food to locate local growers and producers.

I hereby give my consent to the *Friends of the Greenbelt Foundation*, the Ontario Culinary Tourism Alliance and the Greater Toronto Area Agricultural Action Committee to collect, use and disclose to the public the personal and other information I provide to them as they develop and maintain a searchable, publicly accessible, online database of growers and producers located in the Greenbelt and their crops/farm products, and to communicate to me directly about this project and other matters of interest to me as a grower/producer.

I understand that this personal and other information that I provide will be shared among these three organizations and made searchable in various forms to the public, and that they will not otherwise sell, rent or give my personal or other information I provide directly to any other party in any form, (other than any corporation or successor body resulting from any reorganization of any of the *Friends of the Greenbelt Foundation*, the Ontario Culinary Tourism Alliance and the Greater Toronto Area Agricultural Action Committee or sale of their respective assets to a third party).

I also acknowledge that the personal and other information I provide will be accessible to the public via print or other media and by the search functionality of the database and that it is my responsibility to update my information and to correct any inaccuracies.
