*Vacancies on the Board shall be filled using the following procedure:*
  - Any Stakeholder interested in filling a vacant seat shall submit a written application to the Chair and his/her designee.
  - The Chair and his/her designee shall forward the names of all applicants to the Board.
  - The Board shall ensure that the Stakeholder selected meets the criteria for the vacant seat.
  - The Board shall by a majority vote of Board members present fill the position.
  - When such process fills a vacant seat, the Stakeholder shall serve only the remaining portion of the term specified for the seat and the seat shall be filled only until the term expires.
  - In no event shall a vacant seat be filled where a general election is scheduled to occur within ninety (90) days of the date that a written application is presented to the Board.
  - When a vacancy is announced, a minimum of twenty-five (25) days of outreach shall occur prior to filling the vacancy.**7:30**
