## VULTURE FUNDS SWOOP IN ON CONGO

NEW LEGISLATION WOULD OUTLAW VULTURE FUND PROFITEERING

hanks to efforts of the global Jubilee campaign, the Democratic Republic of Congo (formerly Zaire) began receiving debt relief from the World Bank and IMF as part of the Highly Indebted Poor Countries (HIPC) Initiative in 2003 and continues to work to meet the conditions for full cancellation. Now, a lawsuit brought by FG Hemisphere, a known Vulture Fund, threatens to swoop in to profit off of this critical debt relief at the expense of the impoverished people of the DRC.

In 1980, the brutal and corrupt Mobutu dictatorship took out a \$30 million loan with the Sarajevo-based company ENER-

GOINVEST to supposedly construct a hydroelectric facility and an electric power line. The debt remained in default for more than 20 years. After the DRC qualified for debt relief, FG Hemisphere bought ENERGOINVEST's claim for an undisclosed amount. FG Hemisphere pursued the claim in the Washington, DC court system, suing the DRC for \$105 million -- more than three times the original price of the debt. As partial payment, FG Hemisphere tried to seize the DRC's embassy properties in DC. The DC courts rejected this claim, but ordered the DRC to document all of its assets outside the country. The DRC failed to locate all of the documents, arguing that the court's demands were overly broad and burdensome, and now faces the threat of fines of an additional \$4 million per year.

The people of the DRC -- struggling to emerge from crushing poverty, colonial rule, brutal dictatorship, civil war and cold-war intervention -- should not be forced to prioritize repayment of this decades-old debt, taken on by a corrupt and unaccountable regime, plus fines, interest and legal fees. Jubilee USA is leading a coalition working to stop this type of practice by vulture funds. Representatives Maxine Waters (D-CA) and Spencer Bachus (R-AL) introduced the Stop VULTURE Funds Act (HR 2932) in June.

OWhat's New on the Debt Radar

■ Haiti received long-overdue debt cancellation in June 2009 after a multi-year campaign by Jubilee USA and global partners. Haiti will save \$40 million/year in debt payments which can be devoted to urgent social needs. Haiti will receive \$1.2

billion in debt stock cancellation, mostly from the World Bank and InterAmerican Development Bank.

- In June 2009, the Central African Republic became the 25th country to complete the Heavily Indebted Poor Countries program, receiving \$419 million in debt relief. CAR is one of the poorest countries in the world, ranking 171st out of 177 countries in the United Nation Human Development Index. Debt cancellation will help provide support in this country where the average life expectancy is 44 years.
- Debt-ridden developing countries already struggling with the economic crisis will be particularly hard hit if they do not receive some form of debt relief in the immediate future, United Nations Conference on Trade and Development (UNCTAD) Secretary-General Supachai Panitchpakdi warned at a high-level UN meeting in New York in May.

A temporary moratorium on their official debt servicing would give them some breathing space, he said. "In the current global crisis situation", he added, "both debtor and creditor countries would probably be better served if scarcer foreign exchange earnings in the debtor economies were used for the purchase of imports rather than for debt servicing."

### A NEW IMF?


he International Monetary Fund says it has reformed. Messages from the Managing Director, press releases, and news reports say it no longer prescribes the harsh economic loan conditions for which it is known. Yet recent reports from civil society experts show that while the IMF has loosened up on some of its conditionality, it continues to dole out harsh doses of

A recent report by Eurodad found that out of ten low and middleincome countries assessed, five loan programs required wage bill freezes or cuts, including in Cote d'Ivoire, Ethiopia and Malawi, and all had to make spending cuts. This inhibits these impoverished countries from pursuing policies that stimulate their economies like the US and wealthy countries have – spending extra money to create jobs and provide services. In a recession, the world's poorest countries should be allowed to invest more in education, healthcare, and infrastructure - not less.

Thanks to the work of a coalition of NGOs and grassroots activists, Congress included language to improve IMF transparency and protect poor countries' health and spending budgets in their bill to approve \$108 billion in new money for the IMF. Still, the legislators failed to include crucial reforms that would have ensured that the funding achieve its stated goal of global stimulus.

Jubilee USA will continue to push for further reforms, including increased transparency, accountability, and democracy in the institution.

## **CIVIL SOCIETY CALLS FOR** RESPONSIBLE FINANCE

s the global economic crisis devastates the world's poorest nations, the urgent need for financial re-regulation that protects and benefits the poor becomes even more critical. A major global civil society strategy meeting held from June 12-14 outside Rome produced a new wide-ranging platform that offers recommendations for governments and international institutions to create a new framework for lending and borrowing. The charter, called *Transform*ing the International Financial System: Sovereign, Democratic and Responsible Financing would "prevent further build up of illegitimate debt, and move us forward in building a new international financial system."

Jubilee Zambia's Privilege Hang'andu participated in the meeting and spoke of the vision: "We must address socio-economic issues and human realities in the economic architecture if we are to ensure equity and sustainability in the future," say Hang'andu.

The charter will be used to ensure that the voices of those most affected by the crisis are heard. The Jubilee Act for Responsible Lending & Expanded Debt Cancellation would urge the US to support the development of a framework for responsible lending and borrowing.
