

You may notice that combined value of the figures for 'Line Rental' and 'Calls' (a combined total of £100.51) do not add up to the Grand Total (listed at £96.23).

This is because, in her bill, Dawn received a deduction of £3.75, and had a further credit of 53p (a combined total of £4.28). She did not claim for these amounts, and claimed only for the money charged to her by her telephone provider, which was £96.23.

However, she is still required to list the total of 'Calls' amount as it appears on the bill, before deductions, which is the reason for the discrepancy in the two totals.
