## Participant Code of Conduct

- Participants are required to respect the youth workers, the organisers, each other, and to behave politely and appropriately at all times.
- Participants are expected to follow reasonable instructions and requests from the supervising youth workers and event organisers.
- Participants are expected to partake in all aspects of the program however, in case of unforeseen or exceptional circumstances, participation may be negotiated.
- When visiting Parliament House or meeting with Members of Parliament, participants are expected to conduct themselves in an appropriate manner and be dressed appropriately.
- Participants who are under 18 years of age will be supervised at all times during programmed events by guardians/youth workers that parents/guardians have agreed to.
- Participants and guardians are aware that their group leader is responsible for organising transport and accommodation.
- Participants are not to leave their accommodation without informing their supervising leader of their time of departure, estimated time of return and a contact number. However, participants under 18 years of age are not to leave their accommodation at any time, with the exception of outstanding circumstances, which are to be discussed with group leaders and event organisers.
- Participants are *not to* possess and/or consume non-prescription drugs (prohibited drugs) at any time during the Micah Challenge National Gathering. *If participant is found possessing and/or consuming prohibited drugs, organisers will take mandatory legal action.*
- Event organisers have the authority to expel participants from the event who are suspected to possess and/or consume either alcohol or illegal drugs.
