<p>Access to Reproductive Health Care* - H854 – Abortion: Women’s Right to Know, was passed (vetoed by Governor, overridden by NC General Assembly); requires mandatory ultrasound and 24-hour waiting period, state-funded website and physician script, with no exceptions for rape, incest, or fetal anomaly.</p> <p>The 2011 budget prohibits Planned Parenthood from receiving any state or federal funds, thereby denying women access to basic preventive health care, including life-saving cancer screenings and birth control.</p> <p>A “Choose Life” license plate was included in H289, an omnibus license plate bill; proceeds from this plate go to Crisis Pregnancy Centers.</p>	<p>Passed</p> <p>N/A</p> <p>Passed</p>	<p>Planned Parenthood blocked from public funding</p>	<p>↓</p> <p>↓</p> <p>↓</p>

<p>Expand the Definition of “Family” within FMLA – The Caregiver Relief Act was introduced and would provide workplace support for caregivers who provide direct care to certain family members where such leave is not afforded by federal law. <p>Housing Trust Fund Appropriation- For FY '11-12, the Housing Trust Fund’s appropriations were cut by 22%, from \$10 million to \$7.8 million. This is a nearly 50% reduction compared to appropriations six years ago. (H200)</p>	<p>N/A</p>	<p>Funding cut</p>	<p>↓</p>
<p>Protect Childcare Subsidies – The current level of funding for childcare subsidies was maintained, with no increase, and transportation funds for subsidies were eliminated (used to fund free transport to and from child care centers by subsidy recipients). Current funding for child care subsidies falls extremely short of meeting demand, with the program’s waiting list at its highest level ever. (H200)</p>	<p>N/A</p>	<p>Funding cut</p>	<p>↓</p>
<p>Maintain the Earned Income Tax Credit – Efforts to weaken the Earned Income Tax Credit (EITC) were not successful (H93 did not pass but it is still eligible for consideration in the 2012 legislative session). Enhance Open, Ethical Government – Open the legislative process to increase public awareness of who benefits and loses as budget and other laws are considered by providing more rapid, electronic disclosures of how money flows into election campaigns. No legislation introduced in 2011 session.	N/A	N/A	
Protect and Expand Voter Owned Elections – Provide alternative, “clean” source of funding for campaigns so candidates don’t have to rely on large donors and special interests. No legislation introduced in 2011 session.	N/A	N/A	
Protect Voter Rights – Legislation was introduced that would require voters to provide photo identification before voting, making people of color, low-income voters, students and seniors more likely to be discriminated against at the polls. Legislation passed but Governor Purdue vetoed the bill and House was unsuccessful in overriding the veto. The bill is eligible for consideration in the 2012 short session. (H351/S352)	Pending	N/A	
Fight Marriage Discrimination – Ballot measure, Amendment One, to be voted on by all registered voters on May 8, 2012, amends the state Constitution to say that the only valid and recognized legal union is between a man and a woman, explicitly discriminating against same-sex couples, unmarried couples, single parents, and any children of these couples. (S106, revised to S514)	Pending	N/A	
Protect all NC Children – The School Violence Prevention Act (“bullying bill”) and Healthy Youth Act (comprehensive sex education) have been in effect since 2009, and no change in these laws in the 2011 session.	N/A	N/A	
Prevent Racial Profiling – Twenty potentially harmful bills were introduced during the 2011 legislative session, with only 1 bill being signed into law. That bill, H36, requires counties, municipalities, and employers to use the E-Verify Database system. The Speaker created the House Select Committee on the State’s Role on Immigration, which is meeting in the interim.	Passed	N/A

<p>Maintain Funding for Victim Assistance Program – No cuts made to Domestic Violence (DV) funding in the budget, and no cut to Temporary Assistance for Needy Families (TANF) for DV services for WorkFirst participants.</p> <p>The Rape Crisis Center fund, however, was cut by 5%. (H200)</p>	N/A	<p>Funding levels maintained for DV services</p> <p>Funding cut for rape crisis centers</p>	 
<p>Clarify and Enhance Statutes Relating to Violence Against Women – No new legislation filed in 2011 regarding SAVAN, however some progress on the electronic filing pilot program in Alamance County, passed in 2010, that includes automatic notification of protective orders.</p>	N/A	N/A	
<p>Strengthen Response to Criminal Domestic Violence Offenses – Legislation passed the House, now eligible in short session, requiring review of domestic violence offender’s participation in court-ordered abuser treatment program and expands tracking of criminal domestic violence cases to include all acts of domestic violence as defined in Chapter 50B. (H176)</p>	Passed	N/A	
<p>NC Human Trafficking Commission- Within the Department of Administration, the Commission has the power to 1) conduct research on international and domestic trafficking, 2) help inform law enforcement, social service providers, and the general public so that traffickers may be prosecuted, 3) identify gaps, suggest new policies, and develop strategies to eradicate further trafficking. Legislation to create this Commission was filed but did not pass. (S547)</p>	Not passed	N/A	
<p>Require Training on Domestic Violence and Sexual Assault for prosecutors, magistrates, mediators, custody evaluators, parenting coordinators, guardians ad litem, and educators in the public school system – Legislation that would require such training was filed but did not pass.
