**NOTICE OF APPEAL**

Notice is hereby given that pursuant to 1978 NMSA Sec. 62-11-1 (1993) and Rule 12-601 NMRA, New Energy Economy, Inc. (“NEE”) appeals to the New Mexico Supreme Court from the *Order Closing Docket* issued by the Appellee, the New Mexico Public Regulation Commission (“NMPRC”), in Case No. 16-00276-UT on January 31, 2018, attached hereto as Exhibit A.

NEE brings this appeal for review of the NMPRC's decisions. A copy of the NMPRC *Order Granting Motions for Rehearing* of January 3, 2018, attached hereto as Exhibit B; *Revised Order Partially Adopting Certification of Stipulation* of January 10, 2018, attached hereto as Exhibit C, partially revised by the *Order on Notice of Acceptance* of January 17, 2018, attached hereto as Exhibit D, in 16-00276-UT, from which this appeal is taken.
