Peril Strait Landscape Opportunities Project Project Ideas and Next Steps

Summary Report from May 17, 2010 community pre-project meeting

BACKGROUND

This report summarizes project opportunities and ideas, by sector, identified during the May 17, 2010 meeting of the Sitka Collaborative Stewardship Group. These project opportunities are meant to inform the Forest Service of community priorities for planning the Peril Stewardship Project. Opportunities that were identified through other venues than the May 17 meeting are identified in parentheses.

Subsistence

- Enhance sockeye habitat around Sitkoh Lake and creek
- Maintain and improve subsistence resources
- Enhance Sitkoh Lake and Creek sockeye habitat
- Enhance deer habitat

Aquatic Habitat

- Sitkoh River watershed restoration
- Sitkoh Lake tributary habitat restoration
- Fix remaining red pipes
- Partner with Trout Unlimited and Sitka Conservation Society on Sitkoh River Restoration
 minimum \$25,000 available (TU correspondence May 14, 2010)

Terrestrial Habitat

- Restore deer habitat
- Old growth dependent species habitat enhancement
- Invasive species eradication

<u>Timber</u>

- Utilize project second growth and restoration byproducts for vocational training and for rebuilding FS False Island facilities
- Utilize project byproducts for firewood and thermal energy
- Improve access for personal-use wood sales
- Learn more about allowed uses of timber from riparian area restoration
- Assess long-term timber supply priorities

Recreation

- mountain biking trails particularly single-track trails
- ORV trails
- Cabin access and fresh water fish access
 - expansion of trails

- upgrade existing Sitkoh Beach Trail
- Creation of trail from 7554 to Sitkoh East cabin
- bridge construction
- New recreation-use cabin ideas

 - o Florence Bay
 - Sitkoh Bay (partner with State to use LTF site)
 - o False Island

Adaptive management, monitoring, interpretation

- develop UAS course resource and restoration management
- develop robust monitoring program
- apply best available research/science into project
- market feasibility study of commercial use of young growth
- increase interpretation opportunities

Planning and contracting

- Plan joint project with the Sealaska Corporation
- Announce RFP early in the year than March (Fred Einspruch correspondence May 10, 2010)
