Franklyn Becker

1st indic. of poss prob - fall 1970 - report by mother re son - no follow-up

2/22/80 - 2 parishioners aware of "unfort. incident" w/ teenage boy <sup>no name, mother</sup> [redacted]

Becker promised tx + not to do it again, requested transfer

1981 mtg w/ parents of boy + Fr. Janicki seeing Dale Olin

letter to Weak. re committing to celibacy

8/1982 - Fr. Last calls vicar re his bro + sis - intaw - concerned re rel. w/ his son parents told to confront Becker

12/82 - Fr. Heffernan reported to Vicar re Carrillo, cruise w/ boy (mother [redacted])

mother supported Fr Becker

eval in 2/83 - sent to hospital/chaplaincy - gay, never assigned to parish again

1964 - rector learned of rel w/ fellow student sev. rels. w/ teenage boys reported - antic. further acting out

other alleg after 83 no notes '85-1988

'90 - complaint by [redacted] while chaplain at hosp.

newsp-out while seeking weekly tx - under monitoring

 stating they are aware of an unfortunate incident re Jo Buckher re a  
 teenage boy of the name [redacted] at her for support of Buckher  
 ██████████ Central to Washfield, Alaska, Manhattan, Alaska
- 2-11-80 letter of Buckher to Washfield re above of Alaska - project  
 incident of boy; matter will not pose danger; ask for transfer  
 from St Vincent Mary - will meet w Del Olsen
- 1-10-81 Jonichi notes Hoffer reported a matter of 7th grade boy  
 states Buckher in intimate w her son - holding hands during movies,  
 saying she taking during swimming. note filed re parent, teacher & Jonichi  
 Buckher being Del Olsen
- 8-2-81 Buckher writes Washfield re committing self to state of Alaska
- 8-17-82 Jo Last calls Jonichi to report her behavior & requests  
 an council over relationship of Buckher & other teenage son  
 Buckher gives a lot of time when + interaction with w gifts. Parent  
 told by Jonichi to contact ██████████ ██████████
- 12-7-82 Jonichi meets w Buckher who admits bad judgment  
 in taking boy on cruise + admits it he was her nephew.  
 Jonichi recommends going through family w Del Olsen
- 12-10-82 Hoffer reports to Jonichi that 3 mos ago Buckher told  
 some St John J. the publisher how her husband - several staff  
 + trustees, state Buckher made people happy
- 12-22-82 Olsen tells Jonichi Buckher agrees to pay for book  
 at St John J. note, work.
