On 12/13/06 at approximately 14:30 p.m., I spoke with Mark McSwain, Pastor of the First Baptist Church of Bemis. Mr. McSwain stated that for the past several weeks they have had a problem growing in the church with one of their members, Chad Lutrell. Mr. McSwain stated that he has been touching some of the young (approximately 6-10 years old) females in the congregation. Mr. McSwain stated that recently, he had been caught kissing one of them on the mouth. Mr. McSwain also stated that approximately 3 of the adult Women have had problems with him stalking them. Mr. McSwain stated that he has followed them home and has also made physical threats towards them. Mr. McSwain would not say more except that he had sexually harassing them. Mr. McSwain stated that the church is still investigating the complaints on their own now, but wanted advice from the Police as to what to do. I did advise Mr. McSwain that if any of the Victims and Parents of the Victims wanted to come forward and meet with an Officer, we would file their complaints. Mr. McSwain stated that he is trying to follow Biblical guidelines at this point and did not know what would be done. Mr. McSwain would not advise any further on this matter at the time of this report.

On 6/24/09 at 10:20am I went to First Baptist Church in Bemis and spoke with the pastor, Mark McSwain. Mr. McSwain wanted to clarify some information from an earlier report, which involved one of his church members, Chad Lutrell. Mr. McSwain stated in the earlier report it stated that Lutrell had kissed a female juvenile on the mouth. He stated that Lutrell had in fact kissed her on the cheek and he had verified this by speaking with the child and her mother. He also said the earlier report indicated that accusations had been made that Lutrell had been touching juveniles in an inappropriate manner and this too was incorrect. He said no one had ever made any such allegations. He said that the report also indicated that Lutrell had been stalking three of the ladies in the church and making threats towards them. Mr McSwain said that this also was inaccurate that there had been only one incident of him sending an inappropriate e-mail to the young lady and following her home once. Finally, Mr. McSwain wanted to clarify that Chad Lutrell is not now nor ever was an employee of the church as was stated in the newspaper. He said he
