GirlTrek Privacy Policy and Terms of Use

Why do we have this policy?

GirlTrek Incorporated (hereinafter referred to as “GirlTrek”, “we”, or “us”) recognizes that your privacy is important, and we are committed to protecting your personal information. This Privacy Policy applies globally to GirlTrek, including the web pages accessible on our www.GirlTrek.org domain (“Website”), and sets forth our approach to compliance with applicable laws which safeguard privacy and personal information. GirlTrek is committed to protecting the privacy of our users’ personal information and ensuring compliance with laws and practices in relation to privacy, including the provisions of this Privacy Policy.

What does this policy cover?

This purpose of this Privacy Policy is to inform you of our information practices related to the information that you provide when using our Website, including:

- How we collect and use personal information;
- How and when we may disclose or share personal information;
- How we keep personal information secure;
- How we keep personal information accurate;
- How you can change, correct, or remove your personal information; and
- How you can contact us for more information about this Privacy Policy and any suspected breach of this Privacy Policy.

How do we apply this Privacy Policy?

Collection, Use and Disclosure

Our Website may request information from you in connection with registration for GirlTrek activities and events, and in connection with registration for our mailing list. All personal information will only be collected through lawful and reasonable means. Generally, personal information will be collected directly from you, including from our Website. For example, when you register with us, we may request certain information including your name, email address, mailing address and/or zip code, phone number, birth date or year, ethnicity, church and other affiliations, and/or other personal information.

GirlTrek uses information to as part of its health campaign and to further its mission. Information may be used for those purposes in media – both traditional and social media. We only collect, use and disclose personal information which is necessary for us to provide the services offered to you through this Website and to enhance our relationship with our users, as well as to enhance the services we offer to, our users. We will take reasonable steps to ensure that you are aware of the purposes for which we use personal information, except where our collection or disclosure of personal information is required by law.

Except as set forth in this Privacy Policy, we do not disclose, sell, rent, lease, loan or trade any personal information collected on our Website to any third party. We may only share your personal information with others in the following circumstances:

Consent

We will share your personal information with third parties when you consent or direct GirlTrek to share such information.

Providing Services

We may share personal information with third parties only where disclosure is necessary for GirlTrek to effectively provide services to users, to improve existing services or to extend new service offerings. For example, GirlTrek may use your information as journalistic or photographic content to inspire members of the broader organization – through social media or traditional media campaigns. GirlTrek may disclose your personal information to a service provider in connection with the provision of IT or other support services. We may use your personal information to inform you of new initiatives or updates concerning GirlTrek which may be of interest to you. In addition, we provide certain services through links to payment and social media websites. In connection with these services, certain information may be sent to those third parties.

Internal Analysis and Operations

We collect information when you visit our Website such as the number of users, pages accessed and the date and time of visits. GirlTrek collects this information for statistical purposes, and analysis allows us to provide you with an improved service when you revisit our Website. We may outsource some or all of these tasks and disclose personal information about you to third parties, provided the use and disclosure of your personal information by these third parties is restricted to performance of such tasks. We may also share personal information with third-party vendors who assist us in performing internal functions necessary to operate our business. We require our third party vendors to keep such information confidential and to only use the information for the purpose it was provided.

Like many other websites, we may use “cookies.” “Cookies” are text files sent from our server and stored by your web browser on your computer’s hard drive. Cookies allow us to

personalize and save preferences. Cookies can be used to collect anonymous data and serve the user with specifically targeted ads. We do not use cookies to read any data or files in your computer. Most web browsers automatically accept cookies, but you can usually configure your browser to prevent that.

Compliance with Law; Enforcement of Policies

In addition, we reserve the right to disclose any content, records or electronic communication of any kind including without limitation personal information or the content of any "Contact Us" messages received from you: (i) to satisfy any law, regulation, or government request; (ii) if such disclosure is necessary to operate our business; or (iii) to protect the rights, property or safety of GirlTrek or its users, sponsors, providers, licensors or merchants, which may include the enforcement of the Privacy Policy or any other policies or agreements.

We also reserve the right to reject any request for additional information from you or any other user.

Disclosure and Use by Service Providers

Website data (including personal information) is transferred to and stored on servers located in the United States, and operated and processed by GirlTrek or its service providers. By submitting your personal information to the Website, you acknowledge that you fully understand and unambiguously agree to this collection, transfer, storing and processing. We will take all steps reasonably necessary to ensure that your information is treated securely and in accordance with this Privacy Policy, including adherence to applicable laws for the protection of privacy.

Finally, we use and disclose aggregated non-personally identifying information collected through the Website as part of our process of constantly improving our Website and other services.

How we handle "Contact Us" messages

We may preserve the content of any "Contact Us" message that we receive. Any personal information contained in those messages will only be used or disclosed in ways set out in this Privacy Policy.

Security

GirlTrek uses a range of security measures to protect the confidentiality and security of the information we collect online. However, no data transmission over the internet is completely secure. While we endeavor to protect such information, we cannot guarantee or warrant the security of any information transmitted to us, and individuals do so at their own risk. Once any

personal information comes into our possession, we take reasonable steps to protect your information from misuse and loss and from unauthorized access, modification or disclosure.

Accuracy

GirlTrek does not take affirmative steps to confirm the accuracy of the information you provide us. Because the accuracy of our information depends on the information you provide, please contact us at info@GirlTrek.com should your personal information change so that we can update our records. You may also modify, correct, change or update your personal records or cause your personal records to be removed from our database by request via email to info@GirlTrek.com. We will only send personal records to the email address on file for the visitor name associated with it.

Children

We do not intend, and this Website is not designed, to collect personal information from children under the age of thirteen (13). If you are under thirteen (13) years old, you should not use our Website or otherwise provide information through our Website.

Links

This Website may contain links to other websites, which may be of interest to you. Linked websites are responsible for their own privacy practices and you should review those websites for their respective privacy statements and other terms of use before accessing them or submitting any personal information.
