NDARF Goals

- Secure and expand state funding for renewable energy and energy efficiency
- Enhance the production, availability, distribution and use of biofuels in ND
- Achieve significant increases in energy efficiency in ND
- Develop a state policy framework to manage CO2





NDARF Goals

- Invest a portion of the general fund surplus into commercial scale application of next generation energy technologies in which ND has a comparative advantage and that benefit the state
- Protect the wind rights and other interests of landowners and the commercial rights of project developers and owners





NDARF Goals

- Foster development of enhanced geothermal energy in ND
- Maximize retention of wealth in communities created by and through renewable energy and efficiency projects





NDARE Wind Sector Goals

- Protect the wind rights and interests of landowners and the commercial rights of wind
- energy project developers and owners by:
- Providing state information about wind lease/easement contract terms to promote transparency and disclosure and support greater public education relative to such contracts
- Public Service Commission developing a contracting "code of conduct" for wind energy developers who would then be required to notify landowners whether or not they have agreed to adhere to the code of conduct
- Requiring the Public Service Commission to develop rules governing the siting of wind turbines relative to wind rights and property boundaries





House Bill 1509

- Code of Conduct for wind developers
- Passed the House-Amended in the Senate
- Conference Committee
 - Opponents are committed to removing section prohibiting confidentiality clauses
- NDARE is committed to keeping the process open





HB 1426 - Failed

Established wind tower setback guidelines for developers





SB 2033 - Passed

- Extended the tax credit for installation of Wind,
 Solar, Geothermal and Biomass devices
 - Credit of 3%/year for 5 years
 - Extended through 2015





SB 2245 - Passed

- Established a 5 year limit for wind option agreements, easements and leases
 - A contract between developer and landowners terminates after 5 years, unless:
 - certificate of site compatibility or conditional use permit has been issued
 - transmission interconnection request is in process and not under suspension





SB 2031 - Passed

- Extends the property tax credit for wind turbine electric generators from 2011 to 2015
 - Allows developers to reduce tax assessments for another 4 years (Rate of 1 ½ %)





SB 2032 - Passed

- Extends the sales tax exemption for materials used to construct or expansion of windpowered facilities
 - Was to expire 2011, now 2015





HB 1456 - Failed

- Transfer tax credits for installation of wind energy devices between taxpayers
 - ND Tax Dept opposed no way to manage process





HB 1449

- Decommissioning of wind energy conversion facilities
 - Requires wind developers to record the existence of underground foundations not removed at the time a facility is decommissioned.
- Conference committee





HCR 3044 - Passed

- Study the allocation of wind rights in ND
 - How wind rights relate to the surface estate
 - How visual and noise disturbances are addressed
 - Study spacing and placement of wind turbines while protecting property rights
