Dear Mayor Bartlett:

The undersigned advocacy, civil rights, community, and faith-based groups are deeply saddened and troubled by the tragic murder of an Arab American man on August 12<sup>th</sup>, 2016. We write to express deep concern about this incident, and to urge you to direct law enforcement officials to thoroughly investigate all possible motives for this heinous crime.

According to media reports and direct accounts from family members, Khalid Jabara was shot in front of his home by neighbor Stanley Vernon Majors. Mr. Majors was continuously brought to law enforcement's attention for harassing and threatening the Jabara family for years. On the afternoon of August 12<sup>th</sup>, Mr. Jabara was frightened after he learned that Mr. Majors, a felon and known danger, possessed a gun. Mr. Jabara called his mother warning her not to come home because he was worried about what might happen and also informed the police that Mr. Majors was armed. After responding to Mr. Jabara's call, the Tulsa Police Department (TPD) felt nothing could be done and left the scene. Minutes later, Mr. Majors shot and killed Mr. Jabara on the front porch of the Jabara family home.

After her brother's death, Khalid's sister, Victoria Jabara Williams, wrote that her "family lived in fear of [Mr. Majors] and his hatred for years." According to Ms. Jabara Williams, Mr. Majors had repeatedly attacked their ethnicity and perceived religion calling them racist names such as "dirty Arabs" and "filthy Lebanese," as well as "Aye-rabs" and "Mooslems." In 2013, Mr. Jabara's mother was granted a protective order against Mr. Majors after she reported that he harassed her and is "very racist towards foreigners and blacks." As a result, Mr. Majors was prohibited from possessing firearms for the following five years and from going near Mrs. Jabara or their home. Mr. Majors violated the protective order in 2014 after Mrs. Jabara reported to police that he yelled racial slurs at her and threatened to kill her.

In 2015, Mr. Majors ran over Mrs. Jabara with his car causing a broken shoulder, collapsed lung, broken ankle, head trauma, and numerous other injuries. Despite being charged with assault and battery with a deadly weapon, Mr. Majors was released from custody after posting bond without any monitoring while awaiting trial. This was against the pleas of the Jabara family and prosecutor that Mr. Majors was a danger to society and should remain in custody. Less than four months after Mr. Majors was released on bond, he shot and killed Khalid Jabara.

The Jabara family did everything they possibly could to protect themselves from Mr. Majors. As Mr. Jabara's sister stated, Mr. Majors was someone they "continuously brought to law enforcement's attention" and yet he somehow was able to assault Mrs. Jabara and just months later, take Mr. Jabara's life.

At a time of increased anti-Arab and anti-Muslim bigotry, we have also seen hate crimes against Arabs and Muslims occur at alarming rates across the country. Law enforcement officials must take these types of threats and crimes seriously. We were very disappointed to hear statements by TPD officials minimizing the role hatred and bigotry may have played in this crime. Specifically, TPD Sergeant Dave Walker said in an interview to national press, "this is an ongoing dispute with neighbors. Yeah, there is hate, but I don't think the only reason is because they are Middle Eastern." By making this statement, the TPD undermined community confidence that law enforcement officials would conduct an exhaustive and objective investigation.

In recent weeks and months, the Muslim community in Oklahoma has reported numerous instances of violence, including:

- A man [attacked and stabbed](#) a gas station store clerk in Savanna, calling the victim a "terrorist."
- A [vandal targeted a Muslim-owned grocery store](#) in Oklahoma City with hateful anti-Muslim graffiti.

We respectfully urge you to direct the Tulsa Police Department to investigate the heinous murder of Khalid Jabara objectively, thoroughly, and efficiently to ensure that justice is served for the victim and his family.
