## FEES: ACCOMMODATION/REGISTRATION/TRANSPORTATION

- Single: \$1590 per delegate (does not share a room)
- Double: \$1320 per delegate (shares room with another delegate)
- Local Resident: \$880 per delegate (does not require room but meals are provided)
- Delegate & Partner: \$2450 (partner shares room and meals are provided for both). The partner is not registered in a class.
- Round-trip AFL Chartered Bus: \$125 (includes park entry fee)
- Pick-up and Drop-off Edmonton
- Pick-up and Drop-off Calgary
- Pick-up and Drop-off Red Deer

All fees are based on package deals, no exceptions and made payable to the AFL.
