YES ON 1 FOR WOMEN & GIRLS

AN OPEN LETTER TO THE CITIZENS OF ANCHORAGE. ALASKA

As a long-time feminist leader, I feel compelled to reach out to the citizens of Anchorage and urge them in the strongest terms to vote **YES** on Prop 1 for the sake of all the women and girls of your great city, the most populous in a state that is larger than California, Texas and Montana combined! I can tell you as a New Englander that most Americans don't know this and thus the power that you hold in this country.

How is it that an extremely well-funded movement led largely by men representing only 0.3% of the population can obliterate the rights, safety, privacy and the actual *existence* of 50% of the population?! If men can be women in a world of male supremacy where 1 in 3 women will be raped or victims of domestic violence during their lifetime, then it is truly open season on women. Only in an Alice in Wonderland down the rabbit hole world could one imagine such



an absurdity, yet this is today's reality. The authoritarian transgender movement that has metastasized like a cancer was virtually non-existent until the 21st century. Suddenly, laws are passing in cities and states all over the country that deny reality, science, biology and genetics to demand that men be allowed to call themselves women and invade all personal, safe and private spaces for females. Wake up and smell the coffee!

The canary in the coal mine was the Canadian case that began in 1995 of a trans man (a man claiming to be a woman) called Kimberly Nixon who wanted to be trained as a counselor at the Vancouver Rape Relief & Women's Shelter. The women refused and the man sued them, pursuing the case until in 2007 the Canadian Supreme Court ruled against him and awarded the shelter legal costs that Nixon did not pay. Fast forward to today when billionaire trans man "Jennifer" Pritzker used his family fortune to buy candidate Barack Obama and engineer his evisceration of Title IX, created to facilitate equality for females in education and sports, and his transgender in the military policy. Martine Rothblatt, worth approximately \$400 million, is another trans man who finances this movement whose personal agenda is to move on from transgenderism to transhumanism that seeks to use technology to alter the essential nature of human beings. With deep ties to the pharmaceutical industry that will profit immeasurably by using children to block puberty with hormones and creating life-long "customers," this is a movement that should have all of us following the money.

Beyond this backdrop, people need to know what it means to them and their own lives. If you have a daughter, you need to be concerned about male sexual predators having access to their locker rooms, bathrooms and showers since they can simply declare that they "identify" as female and these laws give them total access. This is an absolute gift to pedophiles and voyeurs. A study by the Heritage Foundation documented men charged with sex crimes in intimate facilities in 32 states. If you think this is inconsequential, think again.

Let me make this very personal. As a survivor of domestic violence in which my former intimate terrorist gave me a concussion, black eyes and held me as a hostage in my own home, I can state unequivocally that he would not have hesitated to call himself a woman in order to gain access to me in a domestic violence shelter; a 6 foot, 200 pound man versus a 5 foot, 4 inch, 110 pound woman. Think about it.

How many people reading this know how many feminists have been threatened, no-platformed, bullied, harassed, assaulted, and had their lives threatened by militant trans activists for speaking out in defense of their safety, of biological reality, and indeed their very existence as females? False accusations of "transphobic" are used only to silence. As I stated before, this is a tyrannical, intolerant movement where no dissent is allowed.

I am not a Democrat. I am certainly not a Republican. I am not religious. I am not the T word ("terf" trans exclusionary radical feminist) which should be as odious as the N word ("nigger"). I AM a woman who cares passionately about the protection of the most vulnerable people – females – in a patriarchal misogynist world where females of the species are forced to seek out spaces that are safe from violent male sexual predation.

I urge the people of Anchorage to let sanity prevail over brainwashing and care about the implications of this for your wives, girlfriends, sisters, daughters, mothers, friends, YOURSELVES. REAL transgender people do not say they ARE women, they say they are men who *identify* as women. This is as different as night from day and should tell you all you need to know. I have fought for the rights and protection of the real transgender people and as executive director of CT NOW led the campaign to include transgender people in Connecticut's hate crimes law. What is occurring now as represented by Anchorage's current ordinance is not about "inclusion" but about indoctrination. Think Berlin 1933.
