The plaintiff, by its counsel, undertakes to abide by any order the court may make as to damages in case the court shall hereafter be of opinion that the defendants shall have sustained any, by reason of this order, which the plaintiff

ought to pay.

THE COURT ORDERS UNTIL FURTHER ORDER THAT:

1. Order 2 of the Court's orders made in this matter on Thursday, 6 October 2016

be rescinded.

Pursuant to rule 18.03(1) of the *Supreme Court (General Civil Procedure)*Rules 2015, the first defendant be appointed as the representative of those persons who have been, at any between 6:30am on Wednesday, 5 October 2016 and 6:30 pm on Monday, 10 October 2016, present at and, in any way, a part of a picket line, blockade or protest assembly that has prevented or inhibited the free passage of vehicles or people into or out of the site known as the Geelong Refinery, situated at 80-90 Refinery Road, Corio, in the State of Victoria (which persons are referred to, hereafter, as "the Picketers").

- 3. As soon as practicable and by no later than 10:00 am on Tuesday, 11 October 2016, each defendant place, in a prominent position:
 - (a) on the homepage of its website (at http://www.awu.net.au in the case of the second defendant); and
 - (b) on its Facebook page,
 notification of the making of these orders and a copy of these orders.
- 4. Until the trial of this proceeding or further order:
 - (a) each of the Picketers be restrained from:
 - (i) preventing, hindering or interfering—whether by means of their own physical presence, or by any object or vehicle—the free passage by persons and/or vehicles to or from the site known as the Geelong Refinery, situated at 80-90 Refinery Road, Corio, in the State of Victoria (hereafter, "the Site"); and
 - (ii) advising, causing, inducing, procuring or inciting any person to do or attempt to do any of the things restrained by sub-paragraph 4(a)(i) of this order.

- 5. Until 30 November 2016 or further order, each of the Picketers identified in paragraph 2 be restrained from being present:
 - (a) at any point along Refinery Road, Corio, in the State of Victoria; and
 - (b) within 100 metres of any point of access to the Site,

save for those picketers who seek, via Refinery Road or by other means of access, to attend the Site for the purposes of undertaking work that they have been engaged to perform at the Site.

- 6. There be liberty to apply.
- 7. The costs of today be reserved.

- (A) WHERE THIS ORDER REQUIRES YOU TO DO AN ACT WITHIN A FIXED TIME, YOU REFUSE OR NEGLECT TO DO THE ACT WITHIN THAT TIME;

- (B) WHERE THIS ORDER REQUIRES YOU TO ABSTAIN FROM DOING AN ACT, YOU DISOBEY THE ORDER.
