

AUSTRALIAN MANUFACTURING WORKERS' UNION PROMOTION  
TERMS AND CONDITIONS

1. Information on how to enter this Promotion and Prize details form part of the terms and conditions of entry ("Terms"). These Terms apply to the Promotion and entry into the Promotion is deemed acceptance of these Terms.
2. The Promoter is the Australian Manufacturing Workers' Union, ABN59459725116, 133 Parramatta Road, Granville NSW 2142 ("Promoter").
3. The Promotion will be open from 9:00am AEST on Tuesday 19 May 2015 and will close at 5:00pm AEST on Tuesday 30 July 2015 ("Promotion Period").
4. Entry is open to residents of New South Wales who are financial members of the Australian Manufacturing Workers' Union ("Eligible Entrants").
5. Employees, directors, management and contractors of the Promoter and other agencies, firms or companies associated with the Promotion, and their immediate families, are not eligible to enter. By entering this Promotion you represent that you are eligible to enter.
6. To enter the Promotion and be eligible to win, Eligible Entrants must, during the Promotion Period have paid all membership dues owing to the Australian Manufacturing Workers Union up to June 30 ("Eligible Entry").
7. There is a limit of one entry per Eligible Entrant during the Promotion Period.
8. Eligible Entrants can only enter their Promotion in their own name.
9. The Promoter accepts no responsibility for any entries not received for any reason during the Promotion Period. Entries will be deemed to be accepted at the time of receipt by the Promoter. No responsibility will be taken for lost, late or misdirected entries. The Promoter is not responsible for technical difficulties with the entry mechanism and does not warrant that the entry mechanism will be available at all times.
10. Incomplete, illegible, indecipherable or incorrect entries are invalid. Any entrant who, in the opinion of the Promoter, tampers or interferes with the entry mechanism in any way, or who does not properly comply with the entry process will be ineligible to win.
