

Lincoln County Officials - Punish Man Who Forgot His Dogs In Kennels

Two innocent dogs suffered a long and painful death by starvation after 26-year-old Donald Anthony Armand forgot about them. By the time that they were found - it was far too late. Armand cited going through a "separation" as the reason for forgetting about the dogs who relied on him for care.
