Membership in the Arlington County Republican Committee is limited to 180 members, with each precinct assigned a specific number of members. There are also a limited number of at-large members who are not assigned by precinct. Arlington County may elect up to 365 delegates and an equal number of alternates to the 8th District Convention.

If fewer than the maximum number file for any specific position, all verified filers will be elected automatically.

**If a greater number should file for any specific position, a party canvass open to all legal and qualified Republican voters in Arlington County will be held, on Saturday, March 17, 2018, from 10 A.M. to 2 P.M., at the Walter Reed Community Center, 2909 16<sup>th</sup> St. S, Arlington, VA 22204 in Multipurpose Room A. The candidates receiving the most votes will be elected.
