## About this survey

### Methodology

This document is the candidate’s unedited responses to ACF’S 2019 *Climate Election independent and minor party survey*.

In the survey, the candidate responded to 49 key policy tests, grouped under four broad headings: ramping up renewables, phasing out coal, stopping Adani and protecting nature. Together, these are the priority policy commitments we believe are required to get Australia on the right path, addressing climate change and protecting the people, places and wildlife we love.

Respondents could give five possible responses for each test:

- Support
- Partial support
- No policy
- Oppose
- Comments

We sent this survey to selected minor parties and independents, with a deadline for response by close of business on 25 April 2019. It was beyond our resources to send this survey to the every minor party and independent candidate in every electorate and in both houses. We therefore excluded parties or candidates who:

- Focused on a single unrelated issue, and therefore were not likely to have policies relating to climate, energy or nature;
- Candidates or parties who we assessed to have an extremely low chance of winning a seat (acknowledging this is a subjective judgement).

Many of the independents and minor parties who received the survey did not respond.
