



Bighorn Proposal Comment Guide

The Bighorn Country Survey has been designed to allow you to provide feedback on each proposed area in Bighorn Country. BHA recommends that respondents try to comment on at least the following three areas because they will have the most impact on the backcountry hunting and angling experience and wildlife habitat:

Bighorn Wildland Provincial Park

David Thompson Provincial Park

West Country Public Land Use Zone

Bighorn Wildland Provincial Park

Q2. What else should we consider to help achieve the stated objectives planned for Bighorn Wildland Provincial Park?

a) To support conservation objectives [optional response]

Manage to retain the wilderness nature of the Bighorn. Prior to any development of huts or trails or other infrastructure conduct environmental impact assessments to minimize impact on fish and wildlife habitat. Designate funds for habitat restoration. The use of un-managed or irresponsible motorized off-highway vehicles anywhere in the Wildland Park or development of new trails within the WPP should not be permitted. Off-highway vehicle trails in the Wildland Park that negatively impact wilderness recreation values or fish and wildlife habitat should be removed.

b) To support recreation objectives [optional response]

Manage to retain the wilderness nature of the Bighorn. Ensure that hunting opportunity is retained by allowing bird and cougar hunters to run their hunting dogs off-leash during the hunting season. Designate funds for enforcement to diminish misuse of the area.

c) To support tourism development objectives [optional response]

Huts, trails, and other tourist attractions will detract from the pristine and remote wilderness and diminish opportunity for those who value the Bighorn as a true backcountry destination. Tourism facilities should be located outside wildland parks.

West Country Public Land Use Zone

Q28. How do you want to be engaged in West Country Public Land Use Zone planning process? [optional response]

I want to be consulted on Land-use and Recreation Management Plans that reflect the need for habitat restoration in the area and set science-based limits on motorized roads and trails, management of random camping, protection of threatened native fish species, comprehensive habitat fragmentation analysis of all human activity, and creation of additional areas of non-motorized use. The

management of open motorized trails and roads should be consistent with the science-based thresholds and guidelines established previously for the Livingstone and Porcupine Hills planning areas.

Q29. How do you feel Government could provide additional supports for recreation use in the **West Country Public Land Use Zone**? [optional response]

Land-use and Recreation Management Plans need to be developed to manage the area appropriately for fish and wildlife habitat and recreation. These plans need to include science-based limits on motorized roads and trails, management of random camping, protection of threatened native fish species, comprehensive habitat fragmentation analysis of all human activity, and creation of additional areas of non-motorized use.

Q30. Anything we've missed? Please share any other thoughts or feedback you have on Bighorn Country below. [optional response]

I support the creation of Bighorn Country. I would like to see the following improvements to the Bighorn Country proposal:

- 1. Bighorn Wildland Provincial Park and the proposed Provincial Parks should be managed with the intent of maintaining wilderness. Tourism hubs should be built in or immediately adjacent to surrounding towns and development should be minimized in the parks.**
- 2. Hunting with dogs: Provide provisions in the plan to allow bird and cougar hunters to hunt with off-leash dogs in the Bighorn Wildland Provincial Park and Provincial Parks.**
- 3. Develop recreation and land use management plans for both the West Country and Kiska-Willson PLUZ. These plans should include science-based limits on motorized roads and trails, management of random camping, protection of threatened native fish species, comprehensive habitat fragmentation analysis of all human activity, and creation of additional areas of non-motorized use.**
- 4. Designate funding for habitat rehabilitation and enforcement. A proportion of the \$40 million promised by the provincial government needs to be specifically designated for habitat rehabilitation and enforcement to ensure that habitat and quality of experience is improved and not degraded by the proposed changes.**
