OPEN ONLY TO LEGAL RESIDENTS OF THE STATE OF ARIZONA

THE 2019 BHA ARIZONA MEMBERSHIP DRIVE SWEEPSTAKES (“AMD SWEEPSTAKES”) BEGINS AT 9:00 AM MOUNTAIN TIME (MST) ON 05/01/19 & ENDS AT 11:59 PM MST ON 07/31/19 (“AMD SWEEPSTAKES ENTRY PERIOD”).

ELIGIBILITY: OPEN ONLY TO LEGAL RESIDENTS OF THE STATE OF ARIZONA, age 21 years or older at time of entry. Subject to all applicable federal, state & local laws & regulations. Void in New York State, U.S. Possessions & Territories & where prohibited by law. Employees & their immediate families (parents, children, spouse, siblings) of Backcountry Hunters & Anglers (“the Sponsor”), its advertising & promotion agencies, their respective parent companies, affiliates, subsidiaries, sales representatives &/or distributors, & their immediate families, & those living in the same household (whether related or not) are not eligible to enter.

HOW TO ENTER: There are three (3) methods of entry.

Method #3: Mail-in Card – NO PURCHASE NECESSARY: To enter without making a donation (“mail-in entry”), visit https://www.backcountryhunters.org/az_membership_sweepstakes & follow all entry instructions including printing “Entry Form”, hand-printing all information requested on the “Entry Form” & enclosing “Entry Form” in a self-addressed, postage paid #10 business envelope & mailing via First Class U.S. mail to: 2019 BHA AMD Sweepstakes Entry, PO Box 9257, Missoula, MT 59807-9257. LIMIT ONE (1) ENTRY PER ENVELOPE, PER DAY. ONLY #10 ENVELOPES WITH ONE (1) ORIGINAL “ENTRY FORM” WILL BE ACCEPTED, PHOTOCOPIES WILL BE DISCARDED. LIMIT ONE (1) ENTRY PER PERSON, PER DAY.

For entry methods #1 & #3: Any and all “Entry Form” you are returning must be original and complete or they WILL NOT BE ELIGIBLE for the drawing. Any attempt to exceed this limit may automatically disqualify all entries from that entrant. Potential winners will be notified via email &/or mail &/or courier within 3 business days after random drawing. If a potential winner fails to respond within 14 days, or if notification is returned as undeliverable, that potential winner will be disqualified & an alternate will be determined.
