2020 NEW MEXICO BULL TAG GIVEAWAY
OFFICIAL RULES**

OPEN ONLY TO LEGAL RESIDENTS OF THE STATE OF NEW MEXICO

NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN THIS GIVEAWAY. A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING.

THE 2020 BHA NEW MEXICO BULL TAG GIVEAWAY BEGINS AT 8:00 AM MOUNTAIN TIME (MST) ON 07/22/20 & ENDS AT 11:59 PM MST ON 08/3/20 ("NMBTG GIVEAWAY ENTRY PERIOD").

ELIGIBILITY: OPEN ONLY TO LEGAL RESIDENTS OF THE STATE OF NEW MEXICO, who have either never hunted or never harvested a big-game animal and in possession of a certificate proving that he/she has passed this, or another state's hunter education course or is currently enrolled in the New Mexico Mentored-Youth (MY) Hunting Program. Hunter is responsible for abiding by all NMGF regulations. Subject to all applicable federal, state & local laws & regulations. Void in New York State, U.S. Possessions & Territories & where prohibited by law. Employees & their immediate families (parents, children, spouse, siblings) of Backcountry Hunters & Anglers ("the Sponsor"), its advertising & promotion agencies, their respective parent companies, affiliates, subsidiaries, sales representatives &/or distributors, & their immediate families, & those living in the same household (whether related or not) are not eligible to enter.

HOW TO ENTER: There are three (3) methods of entry.

Method #1: If the option to enter online & make a donation ("online entry") is offered, visit the URL indicated & follow all online entry instructions to enter the Giveaway. Online entries are deemed to be made by authorized account holder of the email address submitted at time of entry.

ONLY #10 ENVELOPES WITH ONE (1) ORIGINAL "ENTRY FORM" WILL BE ACCEPTED, PHOTOCOPIES WILL BE DISCARDED. LIMIT ONE (1) ENTRY PER ENVELOPE, PER PERSON FOR DURATION OF GIVEAWAY PERIOD.**

For entry methods #1 & #3: Any and all "Entry Form" you are returning must be original and complete or they WILL NOT BE ELIGIBLE for the drawing. Potential winners will be notified via email &/or mail &/or courier within 3 business days after random drawing. If a potential winner fails to respond within 7 days, or if notification is returned as undeliverable, that potential winner will be disqualified & an alternate will be determined.
