

**BACKCOUNTRY HUNTERS & ANGLERS
2021 BHA SPRING GEAR GIVEAWAY
Official Rules**

NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN THIS GIVEAWAY. A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING.

THE 2021 BHA SPRING GEAR GIVEAWAY ("GIVEAWAY") BEGINS AT 9:00 AM EASTERN TIME ("ET") ON 3/15/21 & ENDS AT 11:59 PM ET ON 5/31/21 ("GIVEAWAY ENTRY PERIOD"). THE EARLY BIRD PRIZE ENTRY PERIOD BEGINS AT 9:00 AM ET ON 3/15/21 & ENDS AT 11:59 PM ET ON 4/30/21 ("EARLY BIRD ENTRY PERIOD").

ELIGIBILITY: Open only to legal residents of the 50 United States & the District of Columbia, age 21 years or older at time of entry. Subject to all applicable federal, state & local laws & regulations. Void in U.S. Possessions & Territories & where prohibited by law. Employees & their immediate families (parents, children, spouse, siblings) of Backcountry Hunters & Anglers ("the Sponsor"), its advertising & promotion agencies, their respective parent companies, affiliates, subsidiaries, sales representatives &/or distributors, & their immediate families, & those living in the same household (whether related or not) are not eligible to enter.
