### 6. OVERVIEW OF PROCEDURES

#### a. Rules of Order and Plenary Procedures

Aziz provided a brief overview of Robert's Rules of Order—the system of meeting rules and procedures that the Federation employs for plenary sessions, general meeting committee meetings, and caucus meetings—and additional rules and procedures established by standing resolution.

#### b. Anti-Harassment Procedures for the General Meeting

Aziz said that the Federation strives to create an environment at its general meetings that is free of harassment. She said that Internal Affairs Policy F-1 (b) states “at each general meeting of the Federation, plenary shall strike a harassment grievances committee and ratify its members.” She said that the Committee shall be comprised of two women and one man. She noted that two of the members shall be selected by Women's Caucus and the third shall be selected by plenary.

Women Students' Liaison Ruab Waraich provided a brief overview of the anti-harassment policy of the Federation.

Aziz reported that Women's Caucus selected Local 18 delegate Tracy Ho and Local 61 delegate Connie Graham to serve as members of the Harassment Grievance Committee. She said that the general meeting would now select a third, male member of the Committee.

Local 18 delegate Ho nominated Local 18 delegate Aran Armutlu.

Whereas British Columbia student solidarity has proven to be a valuable and powerful tool for progress in the province; therefore,

Whereas academic freedom, in which each group within a campus community is ensured unmolested participation in the education system, is a central moral and social component of quality post-secondary education;

Whereas increasing tuition fees, high student debt, faculty restrictions, and other forces on the post-secondary education system limit academic freedom; therefore,

Be it resolved that Issues Policy, Education Issues, Section A be amended to include:

### **14. Academic Freedom**

#### **Preamble**

Academic freedom is the belief that the freedom of inquiry by faculty members is essential to the mission of the academy as well as the principles of academia, and that scholars should have freedom to teach or communicate ideas or facts (including those that are inconvenient to external political groups or to authorities) without being targeted for repression, job loss, or imprisonment.

Modern post-secondary education brings together many with sophisticated and/or complex beliefs, understandings, and values. Academic freedom includes the freedom to participate in post-secondary education that is free of overt political influence.

#### **Policy**

The Federation supports:

- academic freedom: the right to teach, learn, study, and publish free of orthodoxy or threat of reprisal and discrimination;

- the freedom of instructors and professors to choose educational materials for classes and programs, as long as those materials are sufficient to fulfill the requirements of the curriculum per the Education Council, Senate, or other governing academic body; and,
- limiting non-core required courses and the proliferation of flexible and diverse elective components.

Whereas faculty have been hesitant to support expanded course and program evaluation due to concerns that the results of evaluations will be used against faculty members in disciplinary processes;

Course and program evaluations provide an important venue for students to provide feedback on course and program content, course and program delivery models, and instructor teaching style. Course and program evaluations are also a vital means to provide direct student input into academic and program planning.

**Policy**

The Federation supports the right of students to participate in course and program evaluations conducted among each cohort of a respective course or program. The Federation supports the use of course and program evaluation data to inform changes to course and program content; provide constructive feedback to instructors and professors on teaching style; and inform the academic and program planning at each respective institution.

The Federation opposes the use of course and program evaluation data in by institutions as part a disciplinary action against a faculty member.

Whereas the Anti-Terrorism Act has garnered widespread oppositions from the public, legal scholars, and social justice advocates as well as Members of Parliament including Jean Chretien, Joe Clark, John Turner, Paul Martin, five former Supreme Court of Canada justices, the privacy Commissioner and many legal experts who appeared at the Public Safety Committee; and

Whereas Prime Minister Trudeau has stated that once elected, would strike a parliamentary oversight committee to review “the legislative, regulatory, policy and administrative framework for national security and intelligence in Canada, and activities of federal departments and agencies in relation to intelligence and national security”; therefore
