#### Re: BC Target Benefit Pension Plan – Quick Reference Guide

The system will allow you to see the total value of your pension, history of required contributions received after June 30, 2016, as well as the opportunity to estimate your future pension.

The Pension & Benefits system allows you to create personal accounts where you can safely access and view your secured personal data regarding your pension plan.

There are four steps to creating your account:

- 1. Verify your membership in your pension plan
- 2. Create your account
- 3. Log in and verify your identity
- 4. Access your account and view your data

The Quick Reference Guide to setting up your pension account is included with this letter. The guide refers to an ID number that you will need to set up your account. This ID was sent to you previously.



- iv. Click on Verify Membership





- v. Click on Create Account


