The officer received an important call and could not complete a thorough inspection of this workplace and did not have an opportunity to review the contents of the discussion with the employer representatives prior to leaving the workplace.

The following was discussed:
The personnel indicated that they have not been holding regular monthly safety committee meetings. They also indicated that this workplace has workers from several ministries and the safety committee has more sentation from the various ministries. (Sheriffs, Ministry of representation from the various ministries. (Sheriffs, Minist Attorney General, Court Services, Probationary Services, etc.)

(f) to advise the employer on programs and policies required under the regulations for the workplace and to monitor their effectiveness;

(g) to advise the employer on proposed changes to the workplace or the work processes that may affect the health or safety of workers;

(h) to ensure that accident investigations and regular inspections are carried out as required by this Part and the regulations;

(i) to participate in inspections, investigations and inquiries as provided in this Part and the regulations; (j) to carry out any other duties and functions prescribed by regulation

The employer should also ensure that monthly workplace inspections are conducted.

(OHS3.5) Every employer must ensure that regular inspections are made of all workplaces, including buildings, structures, grounds, excavations, tools, equipment, machinery and work methods and practices, at intervals that will prevent the development of unsafe working conditions.

As a part of a safety committees obligations, they are to be reviewing these inspections to determine their effectiveness.
