

Officer Inspection Text

This inspection, conducted on August 16, 2007 (approximately 09:00 hours) occurred as a result of this officer being contacted by a representative of the Alouette Correctional Centre for Women (ACCW) to ensure the woodshop operation (equipment and facility) met the requirements of the Workers Compensation Act and the Occupational Health and Safety (OHS) Regulation.

ACCW operates a program at this workplace whereby inmates of the correctional centre are instructed, trained and supervised to operate wood working machinery used in the production of cedar outdoor furniture and accessories. ACCW owns the structural building and land occupied by the woodshop facility.

"Marcs Outdoor Furniture" owns and maintains the equipment in the woodshop facility, in addition to instructing, supervising and training the workers (inmates)on the safe use and operation of the equipment.

* General Discussion *

- Discussed with the Assistant Deputy Warden(ADW)that ACCW is operating as the prime contractor of the workplace and as such has the following responsibilities as per WC Act 118(2):
- (a) ensure that the activities of employers, workers and other persons at the workplace relating to occupational health and safety are coordinated, and
- (b) do everything that is reasonably practicable to establish and maintain a system or process that will ensure compliance with this Part and the regulations in respect of the workplace.
