- (1) Since the gym is being used to house inmates, the two gym equipment storage rooms have been reassigned. Storage room "A" is currently being used as a cell extraction training room and storage room "B" is being used for mattress storage. The volleyball and badminton metal poles and nets have been left lying on the gym floor posing a tripping and possible security hazard to workers.
- (2) A plastic chair is being used to support a large microwave oven.

KITCHEN

(3) The emergency gas shutoff valves for the cooking line and deep fat fryers are not readily accessible.

LIVING UNITS

(4) Recent incidents within the Corrections Facilities have indicated unsecured television sets have posed a hazard to correction officers.

EXTERIOR PERIMETER FENCING

(5) A number of workers have stated they have observed unauthorized individuals on the outside of the perimeter fencing which is of a height and spacing that permits contraband to be easily thrown onto the grounds. The contraband entering this workplace may pose risk to the workers.

This is in contravention of the Occupational Health and Safety Regulation Section 4.1.

Buildings, structures, excavations, machinery, equipment, tools and workplaces must be maintained in such a condition that workers will not be equipment, tools and endangered.
