Review of several incidents that occurred at this workplace since 2009 has determined the employer did not immediately undertake an investigation into the cause of all incidents that either resulted in injury to a worker requiring medical treatment, or did not involve injury to a worker requiring medical treatment but had a potential for causing serious injury to a worker.

Specifically, in 2009 there were 20 incidents that occurred at this workplace that meet the definition of violence as specified in OH&S 4.27 and requiring investigation. Of these 20 incidents, the documentation I was provided indicate only 13 were investigated. In addition, in 2010 there were 29 incidents at this workplace meeting the definition of violence as specified in OH&S 4.27 and requiring investigation. Of these 29 incidents, the documentation I was provided indicate only 26 were investigated.

This is in contravention of the Workers Compensation Act Section 173 (1).
