TAKE NOTICE that an application will be made by Mariël Schooff, Daphne Lang, Joyce Hamer, Myrna Allison, Carol Welch and the British Columbia Nurses' Union, to Madam Justice L. Smith at the courthouse at 800 Smithe Street, in the City of Vancouver, in the Province of British Columbia, on March 16, 2010, at 10:00 AM for:

- An Order that Mariël Schooff, Daphne Lang, Joyce Hamer, Myrna Allison and Carol (1) Welch be added as party respondents or, in the alternative, as intervenors in these proceedings;
- An Order that the British Columbia Nurses' Union be added as an intervenor in these (2) proceedings;
- (3)A direction that intervenors added pursuant to this Order:
  - will receive copies of all pleadings and documents exchanged or produced (a) by the parties;
  - may participate in any cross-examinations on affidavits; (b)
  - (c) may submit evidence at the hearing of this action; and
  - may provide written submissions and make oral submissions at the hearing (b) of this action; and
- A direction that any ruting on costs for or against intervenors added pursuant to this Order (4) be deferred until the conclusion of the trial of this action.

The applicant will rely on Rule 15(5)(a)(ii) and (iii), Rule 51(A) and the inherent jurisdiction of the Court.
