## PAGE 2 REGULAR MEETING FEBRUARY 25, 2019

The Township Committee of the Township of Bordentown recessed their regular meeting at approximately 7:03 pm and reconvened the regular meeting at approximately 7:30 pm.

Budget Discussion – CFO & Administrator: Mayor Benowitz stated that the Budget presented this way is complete transparency. Administrator Theokas reviewed his memorandum dated February 25, 2019 regarding the 2019 Budget that he had sent to the Township Committee members. It is a summary of what will be proposed at the March 11, 2019 meeting. The timeline for the Budget would tentatively be March 11, 2019 for introduction and April 8 or April 22, 2019 for public hearing and adoption. A municipal tax increase of 1.7 cents per every \$100 of assessed value is being proposed. It is the first increase in 6 years.

Administrator Theokas said that on Friday, March 1, 2019 and Monday, March 4, 2019 the Public Works Department will be expanding the Construction Office.

The Township continues to perform storm sewer/water repairs and improvements in the Township. Fred Turek and he met with the Bordentown Cemetery Trustees regarding a drainage issue on Independence Drive and encouraged the cemetary to do some improvements to help the residents.

The Culvert repair project is beginning. They are working with School because of some of the bus stops in that area.

The Township had to lien a vacant property at 97 Dunns Mill Road. There is a leakage in the oil tank in the basement. The lien holder is not handling the problem so the Township had to clean it out. There may be an emergency appropriation needed at the next meeting because it is a health hazard. The Township will put a lien on the property.

There are a few small projects punchlist items that need to be completed, with some as soon as the weather breaks. The East Drive road paving project needs completion.

This is the last year of our garbage contract. Administrator Theokas said he is beginning the process now for new specifications. We are looking to possibly going to one-arm bandits.

SID MORGINSTIN, 849 East Drive: Mr. Morginstin asked about the no parking signs on Municipal Drive across from the Senior Community Center. Mayor Benowitz responded that an ordinance was passed because of the site plan approval for the new Wawa. The Township wanted to make sure large tractor trailers did not park there. It is also for safety reasons.

In regard to the Road Program, Mr. Morginstin said there are still a few issues: at the corner of Elm and East Drive and there are a couple of water main breaks. Administrator Theokas stated when weather breaks, punch list items will be addressed. The Township is also working with some of the residents to alleviate discharging sump pumps.

TOM SEAMAN, 18 Arlington Road: Mr. Seaman said he keeps reading about the State's reallocation of school funding. Mayor Benowitz responded that this pertains to the School District, and he suggested Mr. Seaman attend the next school board meeting to ask them.

LEN de GROOT, 8 Arlington Road: Mr. de Groot said he appreciated seeing the change of financial policy for the future. He congratulated and thanked Mr. Elsasser, Mr. Theokas, and the Township Committee for setting the standards and following the process for planning financially. We have a Road Program and now a Financial Program. The AA rating is only the start.
