**Required Inspections**

**Released plans must be on site and available for all inspections**

**Building Inspections**

1. Footings prior to placement of concrete
2. Concrete wall/pier forms prior to placement of concrete
3. Concrete slab prior to placement of concrete
4. CMU (Block) wall mid-point or progress inspection
5. Bond beam inspection prior to placement of grout or concrete
6. Foundation prior to backfill or covering up
7. Open deck inspection-inspection of structural elements such as sill plate, ledger, girders, & joists prior to subfloor or decking being installed when over a crawl space or exterior deck
8. Roof **AND** wall sheathing prior to covering up-may be performed separately
9. Framing inspection (which includes any required fireblocking) **AFTER** electrical, plumbing, and fire rough inspections have been approved
10. Truss systems and bracing
11. Insulation after framing approval and prior to finish materials being installed
12. Above ceiling on a suspended ceiling prior to finish materials being installed
13. In ground pools shall have a rebar (reinforcement) inspection for concrete pools or a collar inspection prior to backfill as applicable
14. Fire and smoke damper (drop test)
15. Final building inspection

**Electrical Inspections**

1. Rough electric inspection
2. Trench inspection
3. Slab inspection (underground)
4. Bonding inspection
5. Service inspection
6. Above ceiling inspection (same as building item #12)
7. Final electrical inspection

**Plumbing Inspections**

1. Rough plumbing inspection-drain/waste/vent and water supply and distribution
2. Slab inspection (underground)
3. Gas pipe inspection and pressure test
4. Fuel oil/LPG piping and tanks
5. Water service inspection
6. Sewer inspection
7. Above ceiling inspection (same as building item #12)
8. Fuel fired appliances
9. Pool drain inspection
10. Backflow inspection
11. Final plumbing inspection

**Fire Inspections**

1. Rough fire inspection prior to closing walls or ceilings
2. Above ceiling inspection (same as building item #12)
3. Hydro/pressure test for all piping systems (underground, suppression, standpipe, etc.)
4. Trench and thrust block inspection/underground pipe prior to backfill
5. Fire pump test
6. Fireplace venting
7. Wet test for kitchen hood suppression systems
8. 100 watt light test on ductwork for class 1 hoods
9. Room pressure test for FM 200 and comparable systems
10. Final fire inspection/testing of all alarm devices and systems and suppression systems

This is not an exclusive list of all inspections that could be required.
