RE: Request for Title and Summary

The undersigned hereby requests preparation of a ballot title and summary of the chief purpose and points of the proposed initiative measure below pursuant to Article II, Section 11(a) of the California Constitution. Below is the text of the proposed initiative and the Notice of Intent to Circulate Petition:

Text of the Initiative

THE PEOPLE OF THE CITY OF BREA DO ORDAIN:

SECTION 0: This initiative shall be known as the, **"BREA CITY COUNCIL TERM LIMIT ACT"**. **SECTION 1:** Those who may be affected should take note of this initiative and read the text to explore any potential adverse impact to their ability to serve in future years.

SECTION 2: To broaden opportunities for public service and to encourage elected officials to be responsive to their constituents, an ordinance shall be adopted providing that no person shall serve more than a total of two (2) terms as a member of the Brea City Council, whether served consecutively or non-consecutively, with any portion of a term, whether elected or appointed, counting as a full term. **SECTION 3:** If any provision of this measure or the application thereof to any person or circumstance is held invalid, that invalidity shall not affect other provisions or application, and to this end the provisions of this measure are severable.

SECTION 4: This initiative may not be amended except upon voter approval.

NOTICE OF INTENT TO CIRCULATE PETITION (Elections Code Section 9202, 9207) Notice is hereby given by the persons whose names appear hereon of their intention to circulate a petition within the City of Brea for the purpose of passing the **"BREA CITY COUNCIL TERM LIMIT ACT"**. A statement of the reasons of the proposed action as contemplated in the petition is: 1. Term limitations exist for other government offices at the State, County and 25 of the 34 cities in Orange County.

2. Council Members volunteer their time except for a stipend; Term limitations will encourage Council Members to make their time in office count to the fullest.

3. Since, Council members volunteer their time at the behest of the people as citizen representatives; they should limit their terms in order to broaden opportunities for public service to regularly renew the Council with fresh leadership with new ideas for the future of Brea.

I certify that I will not knowingly or willfully allow the signatures for this initiative to be used for any purpose other than qualification of the measure for the ballot.

- b) The certification required by subdivision (a) shall be kept on file by the agency authorized to prepare the title and summary for the proposed initiative measure for not less than eight months after the certification of the results of the election for which the measure qualified, or if the measure, for any reason, is not submitted to the voters, eight months after the deadline for submission of the petition to the elections official.
- c) Failure to comply with this section shall not invalidate any signatures on a state or local initiative petition.
