STANDING ON SACRED GROUND SCREENING CONTRACT

This LICENSE is good for one non-broadcast, public exhibition screening of the film series **STANDING ON SACRED GROUND** (the “FILM”) to an audience estimated of from:

- ___ 1-50 people. The license fee for screening the FILM is \$300.00, plus shipping & handling and applicable tax.
- ___ 51-100 people The license fee for screening the FILM is \$600.00, plus shipping & handling and applicable tax.
- ___ 100+ people. The license fee for screening the FILM is \$990.00, plus shipping & handling and applicable tax.

To upgrade your license to cover a larger audience, or to screen it more than once, send your request to info@bullfrogcommunities.com.

In consideration of payment of the license fee provided for above, the LICENSOR has provided the LICENSEE with one (1) set of the FILM (4 DVDs) to be used for the screening, electronic publicity materials and this license to screen the FILM once. In addition the LICENSOR hereby grants to the LICENSEE, without warranty, a limited, non-exclusive, non-transferable license to screen the FILM on the SCREENING DATE only, subject to the terms and conditions specified herein, as follows:

- The LICENSEE hereby expressly agrees that the FILM shall be used only for the permitted purposes as set forth in this AGREEMENT and for no other purpose.
- The LICENSEE agrees that the FILM may be exhibited in more than one screening on the SCREENING DATE, but that permission for additional exhibition dates must be made to the LICENSOR by email or mail, at the addresses above, and will incur additional licensing fees.
- The LICENSEE agrees that it shall not permit the FILM to be duplicated, sold, loaned, transferred, televised or made available online or to any other party not contained herein at any time or in any manner other than as provided for in this AGREEMENT. With respect to the License granted hereunder, it is expressly understood and acknowledged by the LICENSEE that any rights, title, or interest that the LICENSOR maintains with respect to the FILM are expressly reserved by the LICENSOR.

You may charge admission for this “semi-theatrical” community screening. It includes 1 set of the STANDING ON SACRED GROUND Series (4 DVDs), this License to Screen, access to [Resources](#) for your event, a Screening Guide to help you plan your event and lead a discussion, a Handout, a Poster, Press Stills, and use of our Publicity tools when you [post your event](#).
