In consideration of payment of the license fee provided for above, the LICENSOR has provided the LICENSEE with one (1) DVD copy of the FILM to be used for the screening, electronic publicity materials and this license to screen the film once. - The LICENSEE agrees that the FILM may be exhibited in more than one screening on the SCREENING DATE, but that permission for additional exhibition dates must be made to the LICENSOR by email or mail, at the addresses above, and will incur additional licensing fees.
- The LICENSEE agrees that it shall not permit the FILM to be duplicated, sold, loaned, transferred, televised or made available online or to any other party not contained herein at any time or in any manner other than as provided for in this AGREEMENT. With respect to the License granted hereunder, it is expressly understood and acknowledged by the LICENSEE that any rights, title, or interest that the LICENSOR maintains with respect to the FILM are expressly reserved by the LICENSOR.
