### **PLASTIC PARADISE SCREENING CONTRACT**

This LICENSE is good for one non-broadcast, public exhibition screening of the film **PLASTIC PARADISE** (the "FILM"). The license fee for screening the FILM is \$300.00, plus shipping and handling and applicable sales tax.

In consideration of payment of the license fee provided for above, the LICENSOR has provided the LICENSEE with one (1) DVD copy of the FILM to be used for the screening, electronic publicity materials and this license to screen the film once. In addition the LICENSOR hereby grants to the LICENSEE, without warranty, a limited, non-exclusive, non-transferable license to screen the FILM on the SCREENING DATE only, subject to the terms and conditions specified herein, as follows:

- The LICENSEE hereby expressly agrees that the FILM shall be used only for the permitted purposes as set forth in this AGREEMENT and for no other purpose.
- The LICENSEE agrees that the FILM may be exhibited in more than one screening on the SCREENING DATE, but that permission for additional exhibition dates must be made to the LICENSOR by email or mail, at the addresses above, and will incur additional licensing fees.
- The LICENSEE agrees that it shall not permit the FILM to be duplicated, sold, loaned, transferred, televised or made available online or to any other party not contained herein at any time or in any manner other than as provided for in this AGREEMENT. With respect to the License granted hereunder, it is expressly understood and acknowledged by the LICENSEE that any rights, title, or interest that the LICENSOR maintains with respect to the FILM are expressly reserved by the LICENSOR.
- Should the LICENSEE wish to purchase the DVD that it is screening under license, the fee for this license may be applied to the \$350 purchase price of the DVD. The purchase price includes public performance rights, which is the unlimited right to show the FILM in public provided no admission fee is charged. The LICENSEE understands and agrees that should it wish to charge admission to additional screenings of the FILM, all such screenings must be individually licensed by the LICENSOR and will incur additional license fees.

With respect to the License granted hereunder, it is expressly understood and acknowledged by the LICENSEE that any rights, title, or interest that the LICENSOR maintains with respect to the FILM are expressly reserved by the LICENSOR.
