SCREENING CONTRACT

This AGREEMENT is made to grant (*name of organization*) _____

a single license for the **limited, non-broadcast, public exhibition** of the film **THE WISDOM TO SURVIVE**

(the "FILM") on the (*day*) _____ of (*month*) _____, (*year*) 20__ (the "SCREENING DATE"), in (*city*) _____, (*state*) _____.

I agree that I ("the LICENSEE") shall pay to Bullfrog Films, Inc. (the "LICENSOR") a **license fee in the sum of one hundred ninety-nine dollars (\$199) plus shipping and handling, plus sales tax if applicable**, which shall become **due and must be received by the DISTRIBUTOR at least ten (10) days prior to the date** of this AGREEMENT. In consideration of payment of the license fee provided for above, the LICENSOR will provide the LICENSEE with a screening package which shall consist of one (1) DVD copy of the FILM to be used for the screening, and which must be returned to the DISTRIBUTOR (the "SCREENING COPY"); ten (10) consumer DVDs for resale; one hundred (150) postcards (together the "SCREENING PACKAGE"). In addition the LICENSOR hereby grants to the LICENSEE, without warranty, a **limited, non-exclusive, non-transferable license to screen the FILM** on the SCREENING DATE only, subject to the terms and conditions specified herein, as follows:

- The LICENSEE hereby expressly agrees that the FILM shall be used only for the permitted purposes as set forth in this AGREEMENT and for no other purpose. _____ (*Initial Here*)
- The LICENSEE agrees that the FILM may be exhibited in more than one screening on the SCREENING DATE, but that **permission for additional exhibition dates must be made to the LICENSOR by email or mail, at the addresses above, and will incur additional licensing fees.** _____ (*Initial Here*)
- The LICENSEE understands and agrees that **the ten (10) consumer DVDs** which are included with the SCREENING PACKAGE:
 - (i) **may be re-sold for personal use only;**
 - (ii) **may not be screened in public, duplicated, televised, or made available online;**
 - (iii) **may not be donated to any educational institution or library;**
 - (iv) **will not be refunded if returned to the distributor.**_____ (*Initial Here*)
- The LICENSEE agrees that **the FILM may be not exhibited before an audience to whom admission is charged for the viewing of the FILM or from whom a designated admission donation or fund-raising contribution is required.** _____ (*Initial Here*)
- The LICENSEE agrees to **return the SCREENING COPY to the LICENSOR within two days following the SCREENING DATE.** For each day's delay in depositing the SCREENING COPY for return in the Post Office, UPS, or another freight company, 50% of the License Fee (\$99.50) shall be due. _____ (*Initial Here*)

- The LICENSEE agrees that **it shall not permit the FILM to be duplicated, sold, loaned, transferred, televised or made available online or to any other party not contained herein** at any time or in any manner other than as provided for in this AGREEMENT. _____ (*Initial Here*)

With respect to the License granted hereunder, **it is expressly understood and acknowledged by the LICENSEE that any rights, title, or interest that the LICENSOR maintains with respect to the FILM are expressly reserved by the LICENSOR.** This AGREEMENT constitutes the entire understanding of the parties with respect to the subject matter hereof, and any amendments, changes, or modifications shall have legal effect and be binding only if made in writing and signed by both parties.
