### IMPORTANT CHECK LIST BELOW

**Proxy form must be received no later than noon on Saturday, September 7, 2019 at the Proxies & Credentials Desk. Proxies received after noon on Saturday will not be accepted.**

1. In order to vote on Sunday, all proxy holders must pick-up their official Proxy badge(s) at the Proxies & Credentials Desk on Sunday, September 8, 2019. Photo ID will be required to pick up the Proxy badge.
2. A maximum of two proxies may be held by a Delegate or Associate Delegate.
3. Only original signatures are acceptable. Copies of signatures such as a facsimile or photocopy will be rejected.
4. Only voting Delegates or Associate Delegates in good standing may be proxy holders.
5. Dues of both the Delegate and Associate Delegate who is designated as proxy holder must be paid by 8:00 p.m. on Saturday, September 7, 2019 before the proxy can be deemed valid.
6. Cross-outs or white-outs in the proxy giver name or proxy holder name sections will not be accepted.
7. The Delegate granting a proxy may revoke or change the proxy holder only in writing.
8. If a Delegate issuing a proxy is registered at the convention, the Delegate's badge must be surrendered to the proxy desk. If the registered Delegate's badge is not surrendered to the proxy desk, the designated proxy holder will not be able to pick up that Delegate's proxy. If the registered Delegate wishes to stay at convention and attend General Session after surrendering his/her Delegate badge, a replacement Guest badge may be issued.
9. The proxy holder must be registered for convention in order to carry a proxy and be eligible to vote on any issue at the convention's General Session.

ALL PROXIES MUST BE PICKED UP NO LATER THAN 1:00 P.M. ON SUNDAY, SEPTEMBER 8, 2019, AT THE PROXIES & CREDENTIALS DESK.
