### - 48-Hour CC Votes & Results:

• 48 HOUR VOTE - PROPOSAL TO CERTIFY GREEN PARTY OF YOLO COUNTY - THE VOTING PERIOD STARTED 9/17/21 at 10:54 pm and ENDED at 10:55 pm on 9/19/21. Full Text of the Proposal is at APPENDIX H.

### - SGA Voting Results (published 10/1 ~6:10pm):

- Item # 223 Bylaws Amendment: To Remove "No Other Candidate" from Bylaws Sections 7-2.4, 8-4.1 and 8-4.3 -- *did not meet 66% threshold (failed)*
- Item # 224 Bylaws Amendment: To Change Thresholds from 2/3 to 60% (3/5) in Bylaws Sections 6-4.1, 6-5.2, 7-2.3, 7-4, 8-5.1, and 13-2.1. - did not meet 66% threshold (failed)
- Item # 225 Bylaws Amendment: To Change Article 12 of the GPCA Bylaws: Delegates to the Green Party of the United States met 66% threshold -- *Approved*.

(7) CC Workplan and Budget Request: the Budget Committee (Justin Richardson, Maxine Daniels and Karen Nyhus) gave the CC an update and requested input on expenses the CC would like to include in its budget request.

Proposed: CC will submit a budget request \$20/month for BaseCamp (\$240 total), \$250 for membership in Healthy California Now, \$200 for Zoom costs at meetings including GAs, and \$200 to hire someone to train our facilitators and vibes-watchers on handling disruptive conduct in our meetings. Passed by consensus.

Committee will continue to request budget numbers, narratives and workplans. Next meeting of the Budget Committee is Oct. 7, 7 pm.

- 3. Announcements and member's activities:
- Rick: there will be a women's reproductive rights action on Oct 2nd in repones to recent TX ruling. GPSD will be participating, and this maybe a nationwide action? Rick will send info to CH.
- Barry: California Nurses Association (CNA) is organizing an action against CVS which has been funding anti-single Payer lobbying organizations, he'll send info to the group. Healthy California Now campaign has not yet endorsed AB1400 and have not been organizing for any actions. Barry is working on getting an article out for Bayview newspaper on funding mechanisms for AB1400 and will share a draft soon.
- 4. Clearinghouse Report (Nassim):
- CH is sending out eblasts once a month, last one on Sept 8th included GPCA press release on SGA Recall election vote and a few other segments, and had 16-18% open rate.
- CH has received and responded to ~11 inquiries about the recall and GPCA's position.
- CH can re-start the campaign to ship small inventory of t-shirts for \$25 donations. Barry volunteered to manage the shipping.
- 5. Candidates and Elections
- Richard noted the email from Greg Jan on recommendations for candidate endorsements sent to SGA.
- Rick noted there is a candidate in SD county (non-Green) for statewide race for Superintendent of Board of Instructions.
- 6. Strategic Discussions
- Rick brought up the need for a vision and strategic planning for GPCA. Is GROW the right place to have this discussion? There was general agreement that it was.
- Discussions ensued on how do we address the issue of growing the party?
- Nassim: one main challenge in growing GPCA is that we must address is the internal disruptions and hostilities by a hand full of people that cause long time Greens/volunteers to leave party building or leave the party entirely. We see the same challenges at the national level.
- Richard: we must go on and try to get our message out, despite the opposition we see externally.
- Mica: we have no choice but to forward. But everyday we are being governed and represented by Dems and Reps so we need to engage our electeds and tell them what we expect of them.

Any significant actions the Committee/Working Group is taking:

- 1. We are continuing to meet approximately monthly with the Peace and Freedom Party (about "splitting the statewide races" next year so we won't "take votes from each other"). P&F has now identified candidates for US Senate and Insurance Commissioner (who previously ran for those seats), as well as for State Treasurer -- and we have candidates for Secretary of State, Controller and Attorney General. (Pleaser also see the last item in this section, below). Also, with the Peace and Freedom Party, we'll likely be using the name "Left Unity" for our "joint slate".
- 2. As previously reported, to help increase the likelihood that Green candidate(s) in at least one of the statewide races will be able to get 2% or more of the vote (the minimum needed to maintain our ballot status), we've contacted six Californians with relatively high name-recognition (Erin Brockovich, Angela Davis, Danny Glover, Jello Biafra, Dave Anthony, and Matt Gonzalez) to consider running for Governor, but only Dave Anthony and Matt Gonzalez replied -- they were both flattered, but declined. We have also contacted indigenous environmental activists Pennie Opal Plant and Isabella Zizi (Izzy), who both declined, and former SF Mayoral candidate Francisco Herrera, and Keith McHenry of Food Not Bombs, both of whom did not reply. In addition, we also contacted 6 environmental groups, but none of them replied either. But just a few days ago we heard back from a potential candidate who wants to discuss running for Governor with us, so we'll be having a Zoom meeting with him this coming Tuesday -- and if he does decide to run, we'll of course let you know as soon as that's confirmed. However, if he declines, then we'll likely contact a few more activists, and perhaps a few more "big names" too, etc.
- 3. The IT committee sent out our email message to individual Greens back in April, asking for suggestions of statewide candidates, and also inviting people to volunteer and donate for the statewide candidate campaigns. We've now received perhaps \$500 in donations and a couple of Greens whom we're in touch with volunteered to help out when the campaign begins.
- 4. We've submitted info for the SGA vote on endorsing the 6 statewide "Left Unity" candidates, and as soon as that's official, then we can start working with them on their campaigns, especially to help prepare for the start of December signature-gathering and to help raise money for candidate statements, etc. Unfortunately, some SGA delegates have posted messages arguing against endorsing some or all of the candidates, so hopefully you'all can help post messages, so we can get our statewide candidates endorsed! (The vote ends on Sunday, 10/10).

Continued work by the Committee/Working Group will include:

- (1) We're continuing to go through lists of previous Green candidates and activists to identify good statewide candidate prospects, especially for Governor.
- (2) We will also be working on a "Needs Assessment", which will list various "needs" for the GPCA to undertake in order to have the best campaign possible for our statewide candidates. However, our top priority right now is to identify a Governor (& Lt. Governor) candidate(s).
- (3) As we have been, we are planning to continue meeting every other week, on Thursday evenings

We need some kind of basic orientation to SGA/GA, with less jargon, perhaps bylaws skeleton, graphic of structure (we have stuff like that already developed). Can we piggy-back on CC orientation? Is there something we can send out to counties to help them better prepare their delegate and alternates?

Hypothetical discussion while piloting BaseCamp:

What would it take to move e.g., SGA election discussions online to BaseCamp? Technically, I think it would just require that we:
