Membership Fees and Vendor Requirements

All vendors wishing to participate in Catskill Mountainkeeper Farmers Markets must pay a membership fee, submit a copy of the Certificate of Insurance, provide copies of sales Tax certificate (if applicable) and Kitchen permits from the Board of Health or the Department of Agriculture and Markets (if applicable).

Monticello Farmers Market - \$75/season Liberty Farmer’s Market - \$75/season

Join Both Markets – Discount Fee: If vendors are interested in participating in both markets, which we encourage, we would like to offer a \$25 discount, making \$125 the total membership fee for both Markets. Please submit check to accompany the application.

Certificate of Insurance: At least \$500,000 for general (premise and product) liability insurance naming the Catskill Mountainkeeper as an additionally insured must accompany this application.

Farmers Market Nutritional Program:

- I am interested in participating in the Farmers Market Nutritional Program (FMNP) and will accept FMNP vouchers at the Market. (Only produce growers are eligible)
- I would like more information about the FMNP
- I would like an application for the FMNP when they become available
- I would like to participate in the WIC program.
