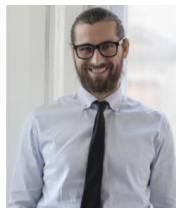
The Commission Welcomes Public Comment!

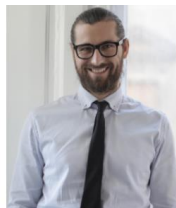
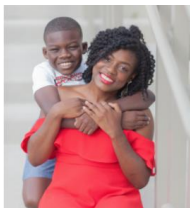
The Commission may not meet on every noticed day. Please consult the website for up-to-date information on the days the Commission will convene.
