Re: San Joaquin County's State Senate, Assembly and Congressional Districts

To Whom It May Concern:

San Joaquin County appears to be on the cusp of a historic opportunity, receiving its own US congressional district. For far too long, we have been represented at the federal level by those who do not reside here or have been sliced to the extent that our congressional boundaries lack coherence. Our equities have too long been subordinated to the interests of those outside San Joaquin County. It is a propitious moment for you to remedy this injustice and for the first time draw a congressional district around San Joaquin County, guaranteeing us the self-determination that is the foundation of representative democracy.

Gill OB/GYN is the county's largest provider of women's healthcare, and we have a multi-generational commitment to the well being of its female residents. The inception of this practice dates back to its predecessor's founding over 70 years ago. Our Co-Managing Partner, Dr. Jasbir Gill, proudly ran the surgical training programs at San Joaquin General Hospital in French Camp and has served as a trailblazing President of the San Joaquin County Medical Society. Dr. Jasbir Gill is also the President of the San Joaquin Foundation for Medical Care, which is synonymous with clinical excellence throughout the entire county from Tracy and Manteca to Lodi and Ripon. He realizes the county-centric healthcare relationships and services that argue in favor of keeping this county whole in congressional reapportionment. Gill OB/GYN maintains five offices in Stockton, and multiple offices in both Lodi and Manteca. Our pioneering medical practice owns shares in a medical office complex in Tracy, California and we anticipate a return to that market in the near future. The women of this community deserve representation in Congress that respects the service area where they receive essential medical services. Dr. Param Gill, our co-Managing Partner, has been chief of staff at two major hospitals in San Joaquin County, trained at San Joaquin General Hospital, introduced women's robotic surgery to the area and is a strong proponent for keeping this entire county together in one congressional seat.

In closing, our practice employs 140 individuals, has nearly 25 medical providers, serves nearly 40,000 patients spread throughout this entire county and has delivered over 90,000 babies in these communities. We are asking the redistricting commission to give us what the residents of San Joaquin County deserve: our own Congressional district.
