

**Proposed Plan and Dates for First Phase of Line Drawing**  
*Line Drawer's Subcommittee (Comm. Andersen & Sadhwani)*

**AUGUST 10 - Full CRC\***

- Training/Recommendation/Conversation on the first criterion and **population deviation** (potential action needed).
- Also VRA Subcommittee: Initial analysis of VRA protected communities using American Community Survey (ACS) data and presentation of "heat map," discussion about general areas where VRA/RPV analysis should be focused.

**AUGUST 19, 31, SEPTEMBER 7 – Full CRC**

- Review of COI submissions through Airtable as available, and regional debriefs of Input Sessions.

**SEPTEMBER 15, 17, 18 - Full CRC**

- Debrief from public input sessions and provide direction to the line drawing team *prior* to the release of the official redistricting database on Sept. 20.

*--Additional CRC Business Meetings are tentatively scheduled for Sept 23, 29, & 30 and could be used for additional discussion as well as possible review of VRA analysis.*

**OCTOBER - NOVEMBER: Full CRC / Public Line Drawing toward Draft Maps**

The proposal is to take an iterative approach to line drawing in which we meet in three day increments to discuss as a commission the input we have received, weigh the impact on our line drawing criteria, and provide direction to our line drawing team to develop visualizations for our consideration.

- **October 3 -Visualization #1 posted**
- **October 4, 5, 6 - CRC Meets to sketch**, looking at areas based on regional focus of line drawing team's mappers – Los Angeles (Jaime); IE/OC/SD (John); North/Central Valley (Willie); North/Coast (Tamina).
  - *Visualizations #2 posted prior to the next line drawing meetings.*
- **October 7, 4-8pm: Business Meeting** (if needed)
- **October 13, 14, 15 - CRC Meets to sketch again by region.**
  - *Visualizations #3 posted prior to the next line drawing meetings.*
- **October 18, 9:30-4:30: Business meeting**

- **October 21, 22, 23**- CRC Meets to Receive **DISTRICT** Maps (appointment system to be established) - open to anyone, individuals or groups wishing to submit district maps for the commission's consideration. (Meetings shall have a two-hour separate time for Line Drawers to get any clarifications from the Commission apart from appointments.)
- **October 25? 9:30-4:30: Business meeting**
- **October 28, 29, 30** – CRC Meets to sketch again.
  - *Visualizations #4 posted prior to the next line drawing meetings.*
- **November 3, 4, 5** - CRC Meets to sketch again.
- **Case 1: November 9, 10, 11** or as long as needed to complete if deadline is **Nov. 13** - CRC Meets to sketch again as needed. (Recommend posting **Friday, Nov. 12** in this Case.)
- **November 12, 1-4pm Business meeting (as needed)**
- **Case 2: November 16, 17, 18** or as long as needed to complete if deadline is **Nov. 20** - CRC Meets to sketch as needed. (Recommend posting **Friday, Nov. 19** in this Case.)
- **November 23 9:30-4:30: Business meeting**
- **November 25:** Thanksgiving Day
- **Case 3: November 28?, 29, 30** or as long as needed to complete if deadline is **Nov. 30** CRC Meets to sketch again as needed

**RELEASE of DRAFT Maps** – Date TBD based upon Supreme Court Decision (or earlier). Recall, the protocols required for draft maps as established in the Constitution:

*Public comment shall be taken for at least 14 days from the date of public display of the first preliminary statewide maps of the congressional, State Senatorial, Assembly, and State Board of Equalization districts, which shall be publicly displayed... The commission shall not display any other map for public comment during the 14-day period. (8253.a.7)*

Recall: **Based on Census legacy release date of August 12, 2021, and using August 19 as SWDB modified/formatted to match PL-94 date:**

- *If map adoption is December 27, Draft maps due no later than November 13. (Aug. 12 legacy)*
- *If map adoption is January 4, Draft maps due no later than November 20. (Aug. 19 modified)*
- *If map adoption is January 14, Draft maps are due no later than November 30.*
- *(Sept. 20 release date of prisoner population reallocated census data, i.e., official California redistricting census data)*

**NOVEMBER/DECEMBER:**

After draft is released following the required protocols, return to public input sessions for feedback.

**DECEMBER:** Return to open line drawing sessions. More exact dates to be determined based upon decision of Supreme Court and final map adoption date.

*\*We anticipate all meetings will be held in a hybrid format, both in person and virtually, but staff will continue to monitor the guidance and regulations by the CDC, state and counties to determine location and format.*
